The following was discussed and suggested:

Use of Technology to increase services for Town residents

- Suggested having an App as a resource for citizens to submit concerns, look at the Town calendar, contacts, etc. 2-3 years. (Baker)
- Suggested upgrading the security camera systems immediately. (Clark-Crets)

Town's Infrastructure

- Suggested staff put the Pavement Condition Index (PCI) on the Town's website so the public can have access to it and a presentation will be given to the Council - short term (Clark-Crets)
- Suggested updating the fee structure. short term (Knisley)

Operations

- Suggested creating a communication policy to guide Council, Commissioners, Committees, and staff to interact with media and public. (Clark-Crets)

Financial Resiliency

Regarding the ½ cent sales and use tax for Loomis Library and Community Learning Center and including park development and funding in

Jesse Lunsford, member of public, suggested the Town begin the process to renew the ½ cent sales tax before Placer County Transportation begins theirs.

Regarding WW Moulding Redevelopment plan and vision for the Town to lease or sale:

- Suggested using train cars or fruit shed theme for the potential buildings on the site. (Clark-Crets)
- Suggested having small spaces to rent for businesses. (Knisley)

Use of the American Recovery Plan Funds:

Linda Kelly, member of public, pointed out that kids have had a hard time with school due to COVID and lack of Wi-Fi/Broadband in some areas,

Community Development

- Suggested having a button on the Town's front page of the website that goes to the General Plan Update and meetings so it can be easier for citizens to find. (Knisley)
- Suggested putting a sign across from the Chamber of Commerce building and at the Corner of King and Taylor Road to let people know we are working on the General Plan and would like them to participate. (Knisley)
- Suggested putting a banner across Taylor Road letting people know about the General Plan and inviting them to participate. (Baker)
- Suggested letting the community know if they get involved their name will be put on the final General Plan document to give them credit. (Clark-Crets)

Bonnie London, member of public, agreed with Councilmember Clark-Crets, to add the people who get involved on the document so when their neighbors see their name, they will know they can talk to them about any questions they may have.

- Suggested budgeting to improve our technology for greater transparency and access for our citizens. (Baker)
- Suggested hiring someone to let us know what technology we need. (Clark-Crets)
- Suggested revising the Tree Ordinance regarding property rights and fee issues. (Cartwright)
- Suggested not charging a mitigation fee for something (tree ordinance) that just sits and cannot be spent. (Baker)

Bonnie London, member of public, stated we don't have a lot of land left in Loomis, so we need to think outside the box on ideas to use the tree funds.

Sean Rabe' suggested we continue to look at modifying the tree ordinance and find ways that the mitigation fees can be more flexible uses.

Jesse Lunsford, member of public, suggested combining the mitigation funds, be more flexible on the use of the funds, and don't use the funds for outside of the Town of Loomis.

Build Community & Transparency

Bonnie London, member of public, stated we need to bring our community together and now would be a good time to do more outreach.

Jesse Lunsford, member of public, questioned why we don't have a Sphere of Influence with long term planning.
