TOWN MANAGER REPORT

LOOMIS CHAMBER OF COMMERCE UPDATE

Jenny Knisley, Loomis Chamber Executive Director, stated the following:

- Loomis Young Professionals hosted their first event
- there are having positive feedback from their leadership classes
- they had a ribbon cutting for Loomis Basin Gastropub, which is now open seven days a week
- nominations for 2019 Business in Excellence Award are out and look forward to celebrating in January

11. County-Wide Transportation Sales Tax

Mike Luken, Executive Director with Placer County Transportation Planning Agency, will give a presentation on the county-wide transportation sales tax

Recommended action: Informational only. Receive and file.

Public comment:

Mike Luken, Placer County Transportation Planning Agency Executive Director, discussed how the county-wide transportation sales tax will effect Loomis, why they are funding the outreach strategy, showed their expenditure plan, major projects and local projects and answered questions.

Sonja Cupler, Tudor Way, questioned how long the sales tax would go?

Jean Wilson questioned how much the sales tax will be and what improvements on Horseshoe Bar Road overpass would be made.

Roger Smith, Wells Avenue, suggested funding for access to Interstate 80 from King Road instead of Horseshoe Bar Road interchange.

David Ring, Delmar Avenue, asked about the Capital Corridor rail.

12. Code Enforcement Update

Lee Holt, Loomis Code Enforcement officer, will give an update on code enforcement and some of the cases addressed within the town.

Recommended action: Informational only. Receive and file.

Public comment:

Lee Holt, Loomis Code Enforcement Officer, gave an update on code enforcement and answered questions.

Sue Dobies stated she supports Lee Holt's increased hours.

Pam Blake questioned if she needed to submit a new complaint regarding her neighbor's fence.

E-Cigarette and Vaping Control Measures 13.

Council directed staff to bring back a summary of potential actions from the October 8th and November 12th Council meetings on electronic cigarettes and vaping related issues. Recommended action: Provide direction to staff on how to address electronic cigarette and

vaping issues in the Town.

Public comment:

Mayor Clark-Crets pointed out that their intention was to ban all flavored products.

Amy McGrath, Placer County Tobacco Control Program, expounded on the State's recommendation on banning all flavored products and answered questions.

Alexander Wride, Placer County Tobacco Control Program, stated that no vaping products are regulated by FDA yet, only on traditional tobacco products and answered questions.

Madeline Cramer, high school senior at Colfax, stated she sees students in the restrooms at school sitting on the floors vaping and vaping during class.

Winston Wong, high school sophomore, stated they sell vape products at school and suggested having more control on the sale of the products.

Sarah Downey, high school junior, stated vaping has become an epidemic at school and the marketing tactics are manipulative such as using flavors that taste good and packaging to attract kids.

Aili Wride, Placer County Youth Commission and attends Rocklin High School, stated kids are selling to each other, buying them online, they are sharing them and using them during class.

Sonja Cupler asked to clarify if this is for e-cigarettes only and if education on vaping is being done at the schools.

William Quenneville pointed out that banning the product won't stop them from using the products, the problem is how to transition them off of the vaping.

Jenny Knisley asked if they are only talking about vaping and not chew.

David Ring pointed out that there is a difference between FDA approved (it has been studied and shown more beneficial then harmful) and FDA cleared (it resembles other products on the market). He also suggested sending letters to the cities around us and our legislators.

Jean Wilson encouraged council to ban all flavored products, including mint and menthol and look at making it a community wide effort.

Sue Dobies, Arcadia Avenue, supports banning all flavored products.

Council majority agreed to direct staff on the following:

- 1. Prepare a resolution advising Town residents of the dangers of vaping and e-cigarette use.
- 2. Prepare an ordinance creating an administrative citation and requiring a diversion program for youth under the age of 21 with vaping or tobacco-related products.

3. Prepare an ordinance prohibiting the sale of all flavored e-cigarette cartridges and e-juice in Town.

4. Creating a 1,000-foot radius buffer around schools and parks that prohibits tobacco sales. Existing businesses would be grandfathered in and would not be affected.
