Approval of Fiscal Year 2019-2020 project Sierra College Blvd Third Lane from Brace

Rd to Taylor Rd Identified in the 2018-2023 Capital Improvement Program

Recommendation

Adopt Resolution approving the Capital Improvement Program Project Fiscal Year 2019-2020- Sierra College Blvd Third Lane from Brace Rd to Taylor Rd.

Issue Statement and Discussion

At the October 9, 2018 Town Council meeting, the Council approved the projects identified as the first year (2018/2019) of the 2018-2023 CIP (CIP) update. During that meeting, Council directed Staff to come back with a CIP workshop to discuss the remaining projects and proposed budget. Staff is preparing a workshop for Council but has not identified a date for that workshop.

Projects are budgeted by fiscal year but the actual work to deliver a project often takes several years. The Sierra College Blvd Third Lane from Brace Rd to Taylor Rd is a project that will take multiple years to deliver. Staff needs to begin surveying, environmental clearance and design to ensure that the project can be delivered on time. Staff is requesting approval of the Sierra College Blvd Third Lane from Brace Rd to Taylor Rd identified for fiscal year 2019-2020 as part of the 2018-2023 CIP.

CEQA Requirements

No environmental review is required for this action. The project will undergo its own environmental review. The proposed project is contained within the Town's existing right-of-way.

Financial and/or Policy Implications

Total cost of the project is estimated to be \$1,600,000.

Funding: 20-21 SB-1 RMRA (\$162,000) Transportation Funds (\$165,000), Transportation Reserves (\$473,000), \$800,000 Sierra College Boulevard Impact Fee Program

Staff will continue to aggressively pursue grant opportunities. If grants are obtained they will be used in place of the Transportation Reserves.
