RE: Electronic Lock Replacement

Recommendation

Waive the formal bidding requirements under Section 3.12.110 of the Municipal Code and adopt resolution authorizing the Town Manager to purchase new electronic locks in an amount not-to exceed \$21,183.42.

Issue Statement and Discussion

The Town has several electronic locks on the buildings and facilities throughout the Town. The existing locks are no longer supported by the manufacturer and are extremely difficult to update. The battery packs often fail and are not easy to replace.

The Town has also added the responsibility for the Library. It is important to replace the locks at the Library with electronic locks and to be consistent with the other locks that the Town is responsible for maintaining. It is very difficult to maintain locking mechanisms from several different manufactures.

Given that we need to add locks and replace the existing locks, Staff reached out to several lock smiths. Only one, the Town's usual locksmith, provided pricing to provide the new locks and replace the existing electronic locks. The prices quoted are reasonable and staff recommends using Lively Locks to add and replace the locks per the attached quote.

WHEREAS, the Town's existing electronic locks are over ten years old and their age and condition warrants replacement; and

WHEREAS, the town desires to replace the lock on the Library with electronic locks; and

WHEREAS, the formal bid requirements can be waived as outlined in the Municipal Code Section 3.12.110.C; and

WHEREAS, Lively Locks and Dead Blots Inc provided an estimate to replace the existing locks and place new locks at the Library in the amount of \$19,257.66; and

WHEREAS, the Town Manager requests change order authority in the amount of \$1,925.76; and

WHEREAS, the Town will purchase electronic locks to replace the existing electronic locks and place new electronic locks at the Library.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the Town Council of the Town of Loomis waives the formal bidding requirements under Section 3.12.110 of the Municipal Code and Authorizes the Town Manager to purchase electronic locks at a cost not-to-exceed \$21,183.76.

Dear Dave:

Here is the bid package for the seven locks that we talked about (three at the office, three at the depot, and one at the library). I've included some information from *Alarm Lock*, so that your IT people can get an overview. The *Trilogy Networx* locks using *Ethernet* are the ones we're interested in. Those locks can be programmed from your office. The DTM (data transfer module) that you used to program the existing locks would not be used anymore.

The Alarm Lock sales rep., Mickey Wallis, and I looked at the job. The new locks are similar to the old locks, except you'd be able to program everything from your office, then send the info through the internet to the locks. You'd still have a key bypass for emergencies, you could get in with fobs or cards, or with the keypad, or with an App on a cellphone (which would also require passwords, etc.). You would be able to "lock down" facilities from the central office. You would be able to assign someone a number for the keypad that would only work one time or for a certain number of hours (service personnel). The options are vast.

Your "service provider," whoever you pay for your router service, would have to provide you with an extra "port" on each of your routers. They charge you a monthly fee for that, from what I understand. Your IT people would need to have that set up in order for the locks to work. The *Networx* locks use a "gateway" (like another router) that plugs into the existing router at each location. The "gateway" sort of "blue-tooths" with the lock.

Mickey Wallis, the rep. from *Alarm Lock*, is available to help your IT people set up the computers for the new locks. When he is not available, *Alarm Lock* has an 800 number and help line. *Alarm Lock* also has free webinar classes, some live and some pre-recorded. I'm good with the hardware, but not so good with the computer side of the equation.

Basically, you need four lever-type locks and three panic bar-type locks. Two of the panic bars that you already have (office and depot) are good Von Duprin panic bars and we definitely do not have to replace them. Only the outside keypad/levers would have to be replaced.

At the library, you would need a new Von Duprin panic bar along with the outside keypad/lever. That panic bar will have a vertical rod that locks up at the top of the door, thereby eliminating any problems we might have with wheelchairs. Also, the library door needs a new door closer. We've tried to adjust it in the past, and it still slams. I've put that on the bid as well. We'd have to move the existing deadbolt, and put it below the panic bar, which shouldn't be a problem. Since the staff has mentioned that they are intermittently having problems with their keys, I am also including a new deadbolt in the bid. By the way, for fire compliance, we should at least have a sticker above the door (on the inside) that reads, "This Door to Remain Unlocked During Business Hours." I have those stickers.

The Networx locks for the panic bars, in the dark brown color, take three to six weeks to get from Alarm Lock. All the other parts are in stock at my suppliers.
