# Recommendation

Approve resolution certifying compliance with the 2020-2021 appropriations limitation and establishing the appropriations limit for 2021-2022.

#### **Issue Statement and Discussion**

This is usually done as part of adopting the annual operating budget, but the State had not provided the growth a population factors until after the budget was adopted.

The Gann limit is a result of Proposition 13, passed by the voters in 1978, that limits the amount of tax that municipalities collect and spend. It takes baseline taxes and expenditures from 1979 (in Placer County) and increases them each year for the cost of living and population change.

You will note that we do not collect taxes anywhere near the upper limit of \$9,387,902 so have no need to fear State sanctions.
