Recommended action: Direct staff and consultant to return with a downtown implementation plan based on the concepts reviewed today, for further consideration by the Planning Commission and Town Council.

Public comment:

Dan Isofano, Landscape Architect and Community Designer, gave the presentation and answered questions.

Gordon Harris, 7835 Horseshoe Bar Road, stated the following:

- you will be bringing young children and dogs to a park by the railroad track
- there should be some kind of containment for frisbies, balls, etc.

Nancy Beck, 6304 David Avenue, stated the following:

- this has been long overdo, with this plan we are capturing what the people of Loomis want
- she asked skaters what they thought about a skate park and they were very excited, she likes the expansion of the skate park

Forest Rinaldi, 2509 Catalina Drive in Sacramento, stated the following:

- he showed a drawing of 218 feet by 95 feet on his laptop for a skate park
- he made it more multi-use
- he has a lowered shade structure, pathways and trees so people can walk through and enjoy the park and still be a skate park

Hilary Wallis, 5600 Tudor Way, stated the following:

- suggested taking the concrete stairs, planters, and corner of benches out
- the skaters don't just want a lot of concrete
- suggested making it flow with the rest of the play area

Jean Wilson, 4301 Barton Road, stated the following:

- suggested a tot lot activity area with benches along the side so parents can supervise
- Rocklin's covered area, where the tables are, gets a lot of use
- she likes the green lawn space because it gives us time to figure out what we want to use if for
- she likes the idea of consulting with the kids
- having a multi-use lawn area is a good idea

Mike Boberg, 4052 Hunter Oaks Lane, stated the following:

- agreed that a tot lot was needed for ages 2-5 years old
- he supports the idea of one-way street along the park
- suggested eliminating the public parking on the park side
- there should only be handicap parking, delivery, and service vehicle parking on the business side of a one way street
- asked if the multi-use skate park would also include inline skating, long boards, etc

Pat Miller, Gold Trail Way, stated the following:

- all the ideas have been positive
- she questioned the multi-use and if it will accommodate other skate uses

Dot Shiro, 9655 Cherokee Lane, endorsed the Blue Anchor Park.

Scott Paris, High Hand Nursery, stated the following:

- his concern is that his building is 40,000 square feet and in order to support it he would not like to see his business restricted
- he has 58 employees that park everyday and on January 30th he is expecting 400 cars coming to a class
- the end of August they will be having a tomato festival sponsored by Placer Grown and expect about 5000
- they will be celebrating 110 years of High Hand
- he supports a large pedestrian pathway where a carriage/hayride could go down behind his business next to the railroad track
- there is no intimacy in a road
- he will work with the Town, his goals are to bring agriculture to downtown but he needs space to do that

Polly Emert, 3403 Reyman Lane, stated the following:

- they have been flexing a lot for Mr. Paris
- the businesses at the other end need help too
- Christiansen's and Nelthorpe's don't have enough parking
- we need to look at the whole Town and not just High Hand

Councilmember Scherer stated the following:

- he has mixed feelings about everything suggested for the park, if we try to put too many things then nothing will be large enough to use
- we need to make sure we have enough room for the concepts
- if we want people in the summer than we need shade
- it's important to have a meeting with the youth for the skateboard park
- we could ask the JACL (Japanese American Citizens League) if they would be interested in designing a low maintenance Japanese garden
- suggested having a special meeting with the Board of Directors of the Heritage Foundation and notify the members to attend regarding the Blue Goose area
- it is important that we put a plan in place for the entire downtown area

Randy Elder, Heritage Foundation, stated that they would like a meeting with the Council regarding the Blue Goose property.

Councilmember Morillas suggested the following:

- the road behind Wild Chicken should be one way going towards High Hand Nursery
- there needs to be parking against the buildings for the businesses only
- suggested no parking around the park area

Councilmember Kellev stated the following:

- Scott Paris has established High Hand Nursery as a place that is doing well and the commercial property across the street has become more valuable
- suggested looking more to the West to provide additional parking (past the lumberyard)
- he suggested putting a monument somewhere to recognize the Japanese, those that were taken from their homes and relocated and those that were in the war

Councilmember Ucovich stated the following:

- he agrees with Councilmember's Morillas and Kelley, having the parking away from the park area
- he likes having a lighted straight path for the promenade
- he agrees that they need to work with Scott Paris behind High Hand Nursery
- suggested having room to allow for artwork or a kiosk

Mayor Liss stated the following:

- he would like to incorporate a dog park somewhere, maybe behind the lumber yard with dog friendly drinking fountains
- he would like to include a screen for outdoor films that we can project
- we could have Japanese gardens showing our strong Japanese heritage (hi-lighting the various nurseries in Town)
- he agrees with having a sidewalk close to the road
- he likes the idea of a 10 foot wide road behind High hand for carriage rides, pedestrians, and bikes to help connect the shed to shed
- we should meet with landlords to discuss shared parking needs
