Councilmember Ucovich stated the following:

- he thanked the volunteers that worked with the Relay for Life at the Loomis Elementary School
- Loomis has been picked as the most outstanding pet friendly community in the Sacramento Region

TOWN REPORT

LOOMIS CHAMBER OF COMMERCE UPDATE

Jenny Knisley, stated the following:

- she introduced Kelly Edwards, an intern from Sierra College, who will be working 50 hours at the Chamber
- they met with the economic development committee, Patricia Green, who put together a commercial inventory on what is available for rent in Loomis (a copy was distributed to Council) and they will be updating it once a month
- they are working on the Thursday Night Family Fest for nine weeks in June and July
- regarding the Raise 80, the off- ramps will be open most of the time and the freeway will be closed the 21st and 22nd at night
- she is posting it on the neighborly community boards and their Facebook

Councilmember Wheeler suggested the following:

- regarding the economic development, Sac Region has a new director, Barry Broome
- he spoke at SACOG and is very dynamic and spoke on economic development for the entire region (six counties)
- if there is an opportunity for him to come out here it would be great for the businesses to hear him

The audience should be aware that the Council may not discuss details or vote on non-agenda items. Your concerns may be referred to staff or placed on the next available agenda. Please note that comments from the public will also be taken on any item on the agenda. The time allotted to each speaker is three minutes but can be changed by the Mayor.

Linda Sandahl, President of Friends of the Library, stated the following:

- she read a letter to the Council thanking them for their support and attending the Supervisor's meeting last week regarding the closure of the Loomis Library
- the tentative agreement from the Supervisors, giving us one year to work on a plan, needs to be formalized
- they have obtained 2,700 signatures from people in the area that are very concerned
- they would like to encourage more direct communication and interaction with the Loomis Town Council as they work through this issue
- their meetings are held at 10:00 on the fourth Thursday of every month in the Jesse Helms Room of the Loomis Library

Walt Scherer stated the following:

- the library is an important issue in our community
- the organization that is working on the Loomis Library issue is going to provide leaders for the future
- the Friends of Library are very anxious to have some formal resolution that will give us a year to work on this issue
- we understand that the Supervisors continue to move forward on the planning of the closure of the library's and we would like Loomis to not be on that list

Edward Peterson, 6013 Thornwood Drive, stated the following:

- he was told to call Pat Brechtal, who is running the Blue Goose, regarding the loud music
- Mr Brechtal threatened him with an injunction to never call him again
- he was also requested to call the Sheriff and he did, but they said they would not site the Blue Goose (it is town sanctioned)
- he doesn't know who to call, he thanked Councilmember's Ucovich and Baker because they have listened to him
- he said there is no one in control at the Blue Goose

Rick Angelocci, Town Manager, stated the following:

- he forwarded an email to the council from Randy Elder showing that they have done some testing onsite and they are working on putting insulation under the floor (he will give a copy to Mr. Peterson)
- they have agreed to hire a security firm to be there during every event and shut it down if they start getting too loud
- they are working towards a solution but it will take a little time

12. **Sign Ordinance Amendment**
Consider a proposed ordinance amending Chapter 13.38.040 Prohibited Signs, regarding vehicle off premise signs
Recommended action: Introduce and read by title only an ordinance amending Chapter 13.38.040, Prohibited Signs, of the Loomis Municipal Code
Public comment:

Signs attached to or suspended from a vehicle parked within a public right-of-way, or in a location on private property that is visible from a public right-of-way, including off-premises parked vehicle signs unless the vehicle parked off-premises is actively engaged in the usual business or regular work of the owner). 13. Potential Power Purchase Agreement

Presentation by Energy Saving Pros to consider a Power Purchase Agreement

Recommended action: Direct staff to continue negotiations for a Power Purchase Agreement with Energy Saving Pros.

Public comment:

Brian Pierce, CEO with Energy Saving Pros, stated the following:

- expounded on their company and projects they are working on and have worked on
- they put together a plan to enter into a Power Purchase Agreement with Loomis to construct a carport by the Blue Goose in co-ordination with the Heritage Foundation and a cover over the Town stage on Walnut
- they are proposing a community partnership, reduced Greenhouse Gas Emissions, a new covered community area, increased public awareness, reduced fixed rates and long term energy savings at no cost to the Town
- with a Power Purchase agreement they install the solar, maintain the solar, monitor the solar, they insure the solar and no "out of pocket" expenses for the Town and the Town will buy the power at a discount

Councilmember Baker stated the following:

- the shade structures don't give the small town look, more like an urban environment
- suggested having them behind the buildings along the park area so they are not visible

Jenny Knisley asked if the Chamber, and others that use the stage, will be allowed some input regarding the structure over the stage and if it will allow lighting underneath for musicians that are using it?

Rick Angelocci stated that the roof structure will not be solar because the panels have about an inch gap so there would be light and rain coming through.

Following further discussion on the matter, the Council consensus was for staff to continue negotiations.

14. Loomis Town Center Implementation Plan Update

Presentation by Bennett Engineering on the Loomis Town Center Implementation Plan Update

Recommended action: Listen to presentation and discuss dates for a second community workshop.

Public comment:

Leo Rubio, Project Manager with Bennett Engineering Services, discussed the following:

- he gave an update on some of the comments they received at their public meeting last year
- reviewed 60% of the design plans and what they have done so far
- they took out the raised medians that were initially proposed
- they widened the sidewalks to 6 to 8 feet wide
- made sure the landscaping wouldn't block the view
- every crosswalk will have warning lights
- there will be another public workshop May 19th and construction will begin the summer of 2016

Meredith Branstad, Principal Landscape Architect, expounded on the following:

- they are looking to preserve the existing trees and replace where trees have died
- they propose permeable pavers to help the trees survive and if the roots start rising the pavers are easy to remove to fix the problem
- they will be expanding the tree wells

Jenny Knisley questioned the design on the corner of Walnut Street and by Stahr Liquor.

Mayor Morillas thanked Bennett Engineering for their presentation.

15. Circulation Element Update

Presentation by Omni-Means on the Circulation Element Update

Recommended action: Listen to presentation and discuss dates for a community workshop.

Public comment:

Marty Inouye, Principal with Omni Means, commented on the following:

- they will be having a workshop in May and expounded on what they have done – traffic counts, speed surveys, Street Saver Program, etc.
- the next task is focusing on updating existing circulation element policies to reflect current legislation
- he compared traffic counts, the increase and projections

Jenny Knisley asked if this includes the Todd Lowell project.

Mr. Inouye said that it does.

Brian Fragiao, Town Engineer/Public Works Directed, stated that the date for the May workshop will be announced at a later date.

Mayor Morillas thanked Omni Means for their presentation.

FUTURE AGENDA ITEMS

Mayor Morillas said she would like two volunteers to work on an Ad Hoc committee with the Friends of the Library.

Councilmember Ucovich said he would volunteer to be on the committee.
