RE: 2009 PAVEMENT MAINTENANCE PROJECT- ACCEPTANCE

#### Recommendation:

Adopt resolution accepting the 2009 Pavement Maintenance Project improvements.

### **Issue Statement and Discussion**

On July 14, 2009, Town Council awarded the 2009 Pavement Maintenance Project to Western Engineering Contractors, Inc. in the amount of \$292,922.00.

This project included the following improvements:

- Pavement Reconstruction on King Road between Sierra College Boulevard and Los Flores Lane
- Pavement Reconstruction on Brace Road from Secret Ravine Bridge to Dias Lane
- Construct additional width of roadway on King Road Day Avenue to Los Flores Lane to accommodate a bike lane and left turn pockets.
- Widen off-street pedestrian paths on King Road from Sierra College Boulevard to Humphrey Road.
- Traffic Stripping and Markings
- Utility Raising

The Town added additional pavement reconstruction work on King Road. The final total project cost was \$334,951.00. This was an increase of \$42,029.00 from the original bid.

Staff initiated a notice of completion (NOC) in October 2009.

#### **CEQA Requirements**

This project was exempt under the California Environmental Quality Act (CEQA) Section 15301. (c&d) (Class 1), "Existing Facilities" of the guidelines.

#### Financial and/or Policy Implications

All money due has been paid. There are no outstanding issues at this time. Western Engineering Contractors, Inc. will be under the one year maintenance warranty once the project is accepted by Council.
