TOWN REPORT

LOOMIS CHAMBER OF COMMERCE UPDATE

Jenny Knisley stated the following:

- they had a successful Loomis family Christmas event last Saturday
- they are working with Gold Country Media on a business relocation visitor's guide for Loomis
- she suggested having the Council consider putting an ad in the visitors guide

Pat Brechtal, Chamber President, stated the following:

- suggested looking at the guide, what they have done in the past, and what we will get, it would be good to see the Council as part of the Town
- he said we should get a good response on the survey for the Sierra Business Council

Irene Smith, 6755 Wells Avenue, read a letter to the Council and expounded on the following:

- previously she had submitted a packet to each of the Councilmembers regarding a project in Rocklin located at Rocklin Road and Sierra College Boulevard
- the property is a 10 acre parcel zoned high density
- a project was proposed about seven years ago and at that time Kathy Kerdus submitted a comment letter regarding the Environmental Impact Report
- there has been major changes since then
- she asked Council to review the current development proposal and submit an updated comment letter to Rocklin requesting they do a full Environmental Impact Report

Roger Smith, 6755 Wells Avenue, stated the following:

- this is a big project that will be at their entrance to Loomis on Rocklin Road
- there will be 400 cars dumped onto Rocklin Road and onto the Sierra College Boulevard intersection
- he pointed out that there was no scoping meeting for the opportunity to make comments, so time is of the essence
- he asked Council to meet with the Borders Committee, voicing concerns and to submit a letter like the previous Planning Director's (Kathy Kerdus)

Edward Peterson, 6013 Thornwood Drive, stated the following:

- he wanted to talk about the noise level at the Blue Goose when they are having events with music
- sometimes the music starts at 1 p.m. to 1 a.m. and during that time you don't hear the music, just the bass, and that causes his windows to vibrate
- he asked Council to look into having some kind of control

Pat Brechtal, 5815 Brace Road, thanked Council for working with him over the last couple of years that he has been President of the Chamber of Commerce.

Desiree Chase, 6245 Arcadia Avenue, stated the following:

- wanted to bring to the Council attention that her home has recently been flooded twice and it is due to the detention pond off of Swetzer Road
- she has been working with Brian Fragiolo, the Public Works Director, in trying to help solve the problem but most of the problem is a long term problem
- she has been forced out of her home numerous times and it is very taxing on her family
- their yard can't handle the water that flows through her yard and she is concerned with the next storm that is coming
- she asked Council if they would expedite a long term solution
