NOTICE INVITING BIDS
Dig Out Repair Project

INSTRUCTION FOR SUBMITTING BIDS

The Town of Loomis is soliciting bids from qualified Contractors to complete the project described herein.

1. **Qualifications:** Contractor shall possess either a valid Class A (General Engineering) or C-12 (Earthwork and Paving), California Contractor's license and a Town business license at the time the contract is awarded.
2. **Project Description and Location:** The specific locations for dig out repairs have not yet been marked as the intent is to meet with the Contractor and mark the location together. The width of removal will be set as the width of the grinder, and payment will be made for the actual tonnage of material removed and replaced along with payment for the daily rate of a grinder. Most of the work is on Larid Road from Wishing Well Way to Horseshoe Bar Road along with a segment of Horseshoe Bar Road to the eastern Town Limits. Budget permitting, the Town may also look to complete dig outs at this time, on next year's residential slurry seal street candidates. All work is in the Town of Loomis
3. **Cost Estimate and Duration:** The estimated cost for the work is \$50,000 with a duration of five working days following the Notice to Proceed. The Town is in a bit of a rush to get this work done ahead of a seal coat project and would ideally look to the successful Contractor to start work within a week of the bid opening.
4. **Bid Package:** Plans and specifications are available free of charge. A copy can be obtained from the City's website or by e-mailing the Town Engineer at the email address listed below.
5. **Pre-Bid Meeting:** A pre-bid meeting has not been scheduled, nor is one anticipated for this project.

7. **Prevailing Wage:** As a "Public Works" project and pursuant to Section 1773 of the Labor Code, the general prevailing wage rates for Placer County shall apply to this contract.
8. **Bid Opening/Reply Format:** All forms in the "Bid Proposal" Section shall be completed and returned to the Town Clerk at the Town Hall, 3665 Taylor Road, Loomis California by the bid's due date. Bids are required for the entire work described herein.
9. **Bid Due Date:** Bids are due on Tuesday June 29, 2021, at 10:00am
10. **Bidder's Security:** Bids must be accompanied by a proposal guarantee amounting to ten percent (10%) of the total bid as described in the specifications. Said guarantee shall be forfeited to the Town in case the bidder depositing the same does not, within seven calendar days after written notice that the contract has been awarded to him (1) enter into a contract with the Town and (2) furnish Performance and Payment Bonds and the required Insurance, as described in the specifications.
11. **Bid Award:** The bid will be awarded to the lowest responsible bidder at the discretion of the Town Manager or Town Council, depending upon the purchase authority required. The Town reserves the right to reject any and all bids, or to waive any errors, discrepancies or irregularities.
12. **Firm Prices:** All bid prices will be held firm for a minimum of thirty (30) calendar days after the due date for submitting bids.
