MATTERS OF INTEREST TO COUNCILMEMBERS/FUTURE AGENDA ITEMS

Councilmember Wheeler recognized Russ Kelley for teaming up with the American Legion and the Lions Club and putting up a tremendous Christmas tree for the Town.

Councilmember Ucovich asked to have on the next agenda discussion of pictures for the Blue Anchor park so people will have a little history of the old fruit sheds.

TOWN REPORT

The time allotted to each speaker is three minutes but can be changed by the Mayor.**

Perry Beck pointed out to Mayor Scherer that he also was privileged to serve in the United States Marine Corps and reminded him that in hard times and decisions they would think back on "what the sergeant would do." He gave Mayor Scherer a memento to remind him in times of hard decisions and wondering what to do--- to think back 'what would the sergeant do.'

Russ Kelley stated the following:

- he asked if the Council noticed that the Christmas tree project in front of the depot is a success
- the American Legion, Post 775, and Loomis Lions wanted to provide a "Loomis Family Christmas Tree"
- he invited everyone to join them December 15th at the Depot from 6 to 7 p.m. to put a family ornament on the tree and the year they became a part of the Loomis Family
- they look forward to establishing a Loomis Family tradition to celebrate our great heritage

Mike Langford stated the following:

- he is a local businessman and has been in the community for 25 years
- he protests the award to Bureau Veritas North America
- he also can do additional services and is collaborating with an engineering and an electrical engineering firm in his submittal
- he worked for Placer County and was in charge of their commercial plan check and did the engineering review
- he performed code enforcement for Placer County and the Town of Loomis
- he asked Council to reconsider staff’s recommendation and consider his firm for this position

Michael Vierra, Bureau Veritas North America, stated the following:

- there staff is made of individuals from around the communities they are working in
- they make every effort to match staff to the needs of the jurisdiction or community that they serve
- their staff includes structural engineers, civil engineers, mechanical engineers, electrical engineers and fire protection engineers
- they have a depth of resources in the area to provide back-up assistance such as having inspectors, plan checkers, fire inspector, and accessibility inspectors

Pat Brechtal stated the following:

- he found out that John Kintz was gone when he called for an inspection and Rhonda Gannon , with Bureau Veritas, came out and treated him with professionalism and knew exactly what she was looking for
- he was very satisfied with Ms. Gannon and it’s good to have an outside person checking on the inspections

Following further discussion on the matter, a motion was made to adopt Resolution 12-29, awarding building inspection and plan check services agreement to Bureau Veritas North America, Inc. and authorizing Town Manager to execute an agreement acceptable to the Town for providing such services. On motion by Councilmember Ucovich, seconded by Councilmember Morillas and passed by voice vote.

Mayor Scherer pointed out the following:

- he didn't see anything about a public outreach and communication plan
- during the Downtown Master Plan Implementation Plan the Council decided that in any future planning for the Town one component in any proposal would be public outreach and communication plan
- the outreach would identify the target groups that would be important to have participating from the community in the plan and how they would contact and encourage their participation
- the public outreach should be in the beginning and not after 60% is completed

Charlotte Langston, President of the Loomis Chamber of Commerce and representing some of the downtown businesses, stated the following:

- the downtown businesses would like to see the Council and members of the community consult business owners downtown
- there is an opportunity to improve downtown business and at the same time preserve the local heritage and not just the road between Walnut Street and Shaun Way
- when they invite people to come and see Loomis those areas don't look like we are preserving heritage and culture, they look like they are run down and we don't care
- they would like to see monuments, landscaping, and sidewalks improved
- parking is a big issue
- she would like to see Bennet spend some time and talk with the business owners and get their opinions

Russ Kelley stated the following:

- one of the key pieces that we need to watch is that no businesses are closed for any reason in this plan
- it is critical that the businesses are not interrupted and this needs to be in the plan

Leo Rubio, Bennet Engineering, stated the following:

- their goal is to make sure the project is successful and public participation is key to this project
- they will make sure that they work with the businesses and make sure there is no conflict in leaving drive-ways open and businesses are open during construction is common with all the streetscape projects they have worked with in the local agencies

Randy Elder stated the following:

- he asked why we are not looking at doing the implementation of the Downtown Masterplan between Walnut and Horseshoe Bar first
- that area is the most walked upon area in town with the post office, town hall and numerous other businesses
- the sidewalks have been buckling because of the trees and that is the biggest hazard we face
- he agrees with Mr. Kelley in helping to protect the businesses during the work
- he has a concern that some of the parking along High Hand might be eliminated
- the businesses and the community need to be consulted in the beginning of this project

Councilmember Morillas suggested bringing this item back in January or February until all the concerns tonight have been addressed.

Councilmember Calvert stated she is ready to make a motion that we adopt this and include some of the comments that have been said tonight.

Councilmember Wheeler stated the following:

- he agrees with Councilmember Morillas, to continue this and get more information on what exactly we are trying to accomplish
- he would like to take a look at the total budget and see if we can make this a larger project
- he asked if there could be some economy of scale by going with a larger project as opposed to smaller phases of this

Councilmember Ucovich stated the following:

- we would need survey work done and crosswalk lighting, etc.
- he would like to know what exactly we are going to get and what it is going to cost
- he is concerned with the median in front of Stahr Liquor and there should be a meeting with the businesses up and down the street by Stahr Liquor to get their input
- he is not sold on hiring this firm, the other firm is qualified and costs less

Mayor Scherer stated the following:

- he wants to recognize the staff has done exactly what the Council has asked
- our number one priority has been improving downtown based upon workshops last year
- with some of the concerns we have he is hesitant to move forward without having the unanimous support of Council
- he suggested not making a motion on this tonight and to put this item on the January's agenda or during mid-year budget review to address some of the concerns that were brought up tonight

Brian Fraggio, Town Engineer/Public Works Director, suggested continuing this item to February and discuss this in the mid- year budget in January.

Councilmember Calvert suggested making sure no other projects, like Caltrans overcrossing construction, is going on at the same time.

Mayor Scherer stated the following:

- he would like staff to look at and take into consideration, when we did the park design downtown, we had a difficult time getting that firm to use creativity in their design
- they tended to use a boiler plate engineering plan to design it and it was difficult to have some creativity in the design
- he would like to see some kind of statement as to their ability to incorporate innovative design and bringing in our heritage into the design

Rick Angelocci, Town Manager, recommended that we will talk about the Capital Improvement Program during the mid-year budget review, have both consultants address these issues, discuss more public workshops at that time, and come back in February for Council's decision.
