3. PROPOSED URGENCY ORDINANCE OF THE TOWN OF LOOMIS ENACTING CHAPTER 13.46 OF THE LOOMIS MUNICIPAL CODE PROHIBITING THE CULTIVATION OF MARIJUANA

REQUEST: October 9, 2015, Governor Jerry Brown signed the "Medical Marijuana Regulation and Safety Act" ("Act") into law; and the Act became effective January 1, 2016 and contains provisions which allow for local governments to regulate licenses and certain activities thereunder; and the Act contains a provision which sets forth that the State shall become the sole authority for regulation under certain parts of the Act, unless, on or before March 1, 2016, local governments have "land use regulations or ordinances regulating or prohibiting the cultivation of Marijuana..." (Health & Safety Code §

<u>RECOMMENDATION</u>: Staff recommends that the Planning Commission recommends that the Town Council adopt the proposed Urgency Ordinance enacting Chapter 13.46 of the Municipal Code Prohibiting the Cultivation of Marijuana

Town Attorney Mona explained the regulation, AB 21 and the change in Urgency status if the governor signs AB 21 removing the March 1, 2016 deadline date for jurisdictions to enact their own regulations

Chairman Hogan asked what the penalties are for the violation of this ordinance Commissioner Duncan asked about the logisitical process involved Commissioner Onderko discussed the difference between the legal use of marijuana vs the cultivation of marijuana Commissioner Wilson discussed the process of changing or amending the urgency ordinance if and when AB21 is signed.

Eugene Harrison – Arcadia Ave , spoke in opposition of the proposed ban on the cultivation of marijuana Leonard Smith – Loomis Basin area, spoke in opposition of the proposed ban on the cultivation of marijuana

COMMISSION COMMENT:

Chairman Hogan spoke in opposition of recommending prohibiting the cultivation of marijuana in the Town of Loomis, Government shouldn't regulate what you put in your body. Don't rush into an ordinance without more research and information Commissioner Onkerko discussed the difference between moral issue of marijuana use and land use issue that cultivation involves. Commissioner Kelly discussed the need to get ahead of the issue and have us be in control of our land use instead of the state. Chairman Hogan opened a discussion exploring the possibility of a moratorium instead of banning cultivation.

Motion was made to request that the Town Council adopt the proposed Urgency Ordinance enacting Chapter 13.46 of the Municipal Code Prohibiting the Cultivation of Marijuana and direct staff to monitor the status of medical marijuana laws adopted by the State and come back to the Commission and Council with possible amendments to the medical marijuana cultivation ordinance. 1.
