# STATEMENT OF ACTION TAKEN DURING CLOSED SESSION

a. No action taken.

### MATTERS OF INTEREST TO COUNCILMEMBERS

Dave Wheeler stated the following:

- SB 16 fills the gap between transportation funding and road maintenance
- they want to add 10 cents a gallon for gas tax and 12 cents a gallon on diesel
- they want to increase the license fees by 1% over the next five years
- they want to increase the vehicle registration fee by another \$35.00
- add \$100 per zero for electric vehicles
- estimated this would be a five year plan
- it is going through SACOG now
- he suggested contacting your State Representative regarding this
- the number one concern of the focus groups is that the money will not be used for what it is meant for
- if this passes the Town will be getting about an extra \$175,000 a year

#### Councilmember Ucovich stated the following:

- he asked if everyone received a letter from Mr. Peterson regarding the sound coming from the Blue Goose
- Mr. Peterson is happy with the noise level now except for the bass
- regarding LAFCO: there is a proposal coming up to annex an area at the end of Sierra College and Hwy 193, a proposal that will add about 23,000 people (larger then Bickford Ranch) that will impact on Sierra College Boulevard
- he wants to make sure that the Town is involved in the Environment Impact Review

#### **TOWN REPORT**

### LOOMIS CHAMBER OF COMMERCE UPDATE

Jenny Knisley stated the following:

- the Library Ad Hoc committee has been meeting every Wednesday, they have been considering renaming to "how they envision the library" instead of "saving the library"
- they created a survey and will be advertising that
- they will be meeting with Gordon Medd, Superintendent for Loomis Schools, to talk about the 21st Century libraries
- the next Board of Supervisors meeting will be on June 16<sup>th</sup> and they might be talking about the libraries and invited Council to attend and support
- she attended the Placer County Visitors Bureau "Why Tourism Matters" meeting
- at the Economic Committee meeting they met with Councilmember Black and they discussed the trees that need to be trimmed so the buildings are more visible and signage
- she attended the Joint Chambers Economic Development Committee with Rocklin, Auburn, Lincoln and Roseville
- they had updates from Placer County Transportation, including a discussion on a proposed increase in sales tax
- the Sierra College Hacker Lab discussed a possible bond on the next ballot
- she announced the Blues, Burgers and Brews event on June 27th
- they have a new logo for the Eggplant Festival that will be going out at the State Fair

All items on the agenda will be open for public comment before final action is taken. Speakers are requested to restrict comments to the item as it appears on the agenda and stay within a five minute time limit. The Mayor has the discretion of limiting the total discussion time for an item. Walt Scherer, Library Ad Hoc Committee, gave a detailed briefing on where they are at regarding the Loomis Library.

The Mayor asked to have this on future agendas for an update on the library.

David Henry, President of the Placer County Fair Association, invited Council to the Placer County Fair starting June 25<sup>th</sup> to June 28<sup>th</sup> and expounded on the events.

Edward Peterson, 6013 Thornwood Drive, stated the following:

- it hasn't been about the music at the Blue Goose, it has been about the bass
- it has gotten better
- he is asked if someone could be in control at the Blue Goose to make sure the bass is turned down

# 11. Proposed Ordinance Prohibiting Wrongful Loitering

At the May 12, 2015 Mayor Pro Temp Baker requested that staff return with an ordinance prohibiting loitering within the Town, specifically at the Town's Train Depot. Complaints have been received by the Sheriff's Department and staff regarding loitering.

**Recommended action:** Take public hearing, and introduce for first reading the proposed ordinance adding Chapter 7.24.010 and 7.24.020 Prohibiting Wrongful Loitering to the Loomis Municipal Code

# **Public comment:**

Jeff Mitchell, Town Attorney, stated the following:

- the loitering definition has to do with staying after business hours or after the park has closed
- hanging out at the park during the regular hours is not a violation because it is a public park
- this will be complaint driven

Jenny Knisley stated they had an experience during the Thursday Night Family Fest when they were having the talent show and while the young girls were singing.

Following further discussion on the matter, a motion was made to introduce for first reading Ordinance 261, adding Municipal Code Chapter 7.20 Prohibiting Wrongful Loitering. On motion by Councilmember Ucovich, seconded by Councilmember Baker and passed by the following roll call vote:

## 12. Operating Budget for 2015/16 Fiscal Year

**Public comment:** 

There was no public comment.

Councilmember Ucovich stated the following:

- suggested putting in a concrete sign to identify the Sunrise Loomis Park and who it belongs to
- the funds could be taken out of the Park Development Fees (about \$3500)
- there use to be two spring animals for the children to play on and he would like to have two more put back in, that is similar

Council agreed.

Roger Carroll, Finance Director, affirmed there would be \$3500 for the sign at the park and \$2500 for park replacement; he will put a total of \$6,000 in for both.

Councilmember Ucovich stated the following:

- he suggested looking into having a temporary freeway sign (maybe a trailer on wheels) put on the Turtle Island property
- we are the only community that doesn't have a sign on the freeway telling what is going on in the community

Roger Carroll pointed out that the Economic Development section has \$10,000 for Town signage.

Councilmember Wheeler suggested bringing the signage discussion back to a future agenda when the Public Works/Town Engineers position is filled.

Mayor Morillas appointed Councilmember Wheeler and Councilmember Baker to be on the mini-grants committee.

Following further discussion on the matter, a motion was made to approve the following:

- Resolution 15-09, adopting the amended annual Operating Budget for Fiscal Year 2015-2016; and
- Resolution 15-10, certifying compliance with the 2014-2015 Appropriation Limitation and establishing the Appropriation Limitation for the 2015-2016 Fiscal year; and
- Resolution 15-11, setting forth Position Allocations for the Fiscal Year 2015-2016.

# 13. Blue Anchor Park Spray Pad

Discussion on a water collection system at the Blue Anchor Park Spray Pad

Recommended action: Discuss and give direction

**Public comment:**

Rick Angelocci, Town Manager, stated the following:

- in Placer County Water Agency's (PCWA) news letter it said water features must be drained and not used
- he contacted PCWA to make sure the Town was not in violation of their restrictions and they sent a letter urging the Town not to be using the spray pad this year

Councilmember Wheeler stated the following:

- it is the perception, that we as a town need to support PCWA
- there is no sense in buying a water collection system if the spray pad will be off

The council consensus was to not proceed with a water collection system and keep the spray pad turned off for the summer.
