MATTERS OF INTEREST TO COUNCILMEMBERS/FUTURE AGENDA ITEMS

Councilmember Liss stated the following:

- the Board of Supervisors hearing on "Stop 150 Apartments," is Thursday at 10:30 a.m.
- October 13th and 14th is the Loomis Basin Horsemen's Association Horseshow
- October 30th is the Placer County Manufacturer's workshop and encouraged all businesses to come out and support

Councilmember Scherer stated the following:

- this afternoon a driver slammed on their brakes and almost hit someone going across the crosswalk in front of Christensen's
- he would like on the next agenda to bring in the folks from the League Convention in San Diego, there was a group that had mid block Crossing lighting that might help hi-light the fact that there is an intersection that is extremely dangerous and we need to address that situation
- this Saturday is the Spectacular Dance at the Blue Goose and the money is for wounded veterans
- the Manda Run is in November to raise money for our local schools and he encouraged citizens to participate in both these events
- there is a Del Oro class reunion in November to raise money for the Del Oro Aquatic Center

Councilmember Ucovich stated he would like on a future agenda, an update on the tree ordinance, a status report on the Park and Recreation Element and when the mitigating Negative Declaration will be done.

Councilmember Scherer suggested having the manager include that in his monthly status report.

Councilmember Ucovich continued stating the following;

- he would like to get a report from the Borders Committee on the rezoning of Rocklin's property on Sierra College Boulevard next to the college
- he would like to get a report from the Town Attorney on his evaluation of our Quimby Act

Mayor Calvert pointed out that the Del Oro All Class Reunion will be held over at the old Rocklin Park Hotel for the Del Oro Aquatic Center.

CONSENT ITEMS FORWARDED

 Neighborhood Electric Vehicle (NEV) Transportation - Award Contract To Bennett Engineering Services For Not-To-Exceed Cost Of \$26,398.03 And Direct The Town Manager To Sign Into An Agreement **APPROVE**

Leo Rubio, Bennett Engineering Services, stated the following:

- the City of Lincoln was able to obtain over \$800,000 from CMAC money through Placer County Transportation Planning Agency
- NEV's are legally allowed on roads that are 35 mph and under if they have all the safety requirements on them such as seat belts, lights, etc.
- they found that in Lincoln the NEV lanes offered the community another mode of transportation rather than just cars

Hazel Hineline, 3443 Barker Road, stated the following:

- she is a well seasoned senior and has lived here for over 34 years
- if a person couldn't drive a car than they shouldn't be driving an NEV
- this is a small rural community that takes care of each other, this issue seems to be for just a few people
- you would have to purchase the land or obtain it by eminent domain in order to put NEV lanes on the south side of the freeway

Jean Wilson, 4301 Barton Road, stated the following:

- one thing that concerns her is that it is being sold to the Town that we have to have this in order to get the bike trails
- on page 3, under special considerations, it doesn't reference anything about bikes and trails
- if this is going to be sold to the public as helping to fund bike trails it doesn't say anything about it
- she is not convinced that NEV lanes are needed in Loomis

A citizen who chooses not to identify herself, stated the following:

- she opposes spending any money on NEV lanes
- it is fiscally irresponsible and she hasn't heard of anyone in the community clamoring or needing NEV lanes

Brian Touie, 8235 Granada Lane, stated the following:

- questioned if the average senior citizen could purchase an NEV
- we have private industries that are doing home delivery such as Safeway
- there are many private companies that are there to help with transportation for the elderly

Kelly Foster, 5360 King Road, stated the following:

- she is opposed to spending \$26,000 on a study for something that is not necessary for our community
- Loomis isn't a community that needs NEV lanes at this time

Brian Baker, 6025 Arcadia Avenue, stated the following:

- questioned what types of communities are adopting these plans
- it doesn't sound safe to put a motorized vehicle in the same lane as children walking to school
- we only need safer trails for our children

Brad Fischer, 8240 Gilardi Road in Newcastle, stated the following:

- he is in favor of the NEV lanes, it is not just senior citizens that would be using them
- putting these lanes in will make it safer by designating a specific lane for the electric vehicles and getting them off the road
- children walking to school would be safe in these lanes because they are plastic electric vehicles going 25 mph
- Loomis should adopt this plan so more can save on gas

Pat Miller, 4395 Gold Trail Way, stated the following:

- this is a feasibility study to find out if it is feasible to do it
- before we do anything we must have this study in order to get matching funds for alternative transportation
- it's not going to happen all at once, she has heard nothing about public domain and taking away private property
- she supports the feasibility study

Following further discussion on the matter a motion was made by Mayor Calvert to have the study include NEV signage where it is available, include where the speeds can be reduced for NEV's, include where there is a major traffic corridor to connect neighborhoods, minimize the taking out of trees, an alternate route through the downtown, enhance our streets where it makes sense and to award the project to Bennett Engineering Services for a not to exceed cost of \$26,398.03 and direct the Town Manager to sign an agreement with the consultant. Councilmember Scherer adding: in order to give our community more choices and not deprive them of this option. On motion by Councilmember Scherer, seconded by Councilmember Liss and passed by the following roll call vote:

12. Area 4 Agency on Aging Presentation for Placer County

At the august 14, 2012, Council requested that a presentation on aging by the Area 4 Agency on aging be scheduled.

Public comment:

Nancy Vasquez, Program Manager for Area 4 Agency on Aging, gave a presentation on aging in Placer County/Loomis and answered questions on some of the following:

- they are funded primarily through the Older Americans Act
- their agency determines what the needs are for seniors and then they fund the senior services in the seven county region in their Jurisdiction
- in order to find out what the needs are they conduct a needs assessment (every four years)
- the number one need in Placer County is transportation
- they provide funding for senior services in Placer County such as transportation, nutrition, senior information and assistance, legal services, caregiver services, in home care, chore services, minor home modifications, etc.

14. Strategic Energy Resources Report

Consider the Participation Agreement with Sierra Business Council (SBC) to prepare a Strategic Energy Resources Report for the Town of Loomis

Recommended Action: Approve the Participation Agreement with Sierra Business Council for the preparation of a Strategic Energy Resources Report

Public Comment:

Council discussed this item after item 8.

Nick Martin, Sierra Business Council, gave a background on some of their programs.

Steve Frisch, Sierra Business Council president, expounded on the following:

- why the Town would consider doing this and what the regulatory climate is for this
- AB32 the California Global Warming Solution Act passed in 2006, it requires the California Air Resources Board to develop regulatory and market mechanisms to reduce green house gas emissions to 1990 levels by 2020 roughly a 20% reduction
- it requires green house gas reporting and reduction strategies be conducted at the local and regional level
- SB 375 passed in 2008 called the Sustainable Communities and Climate Protection Act, this requires to develop green house gas emissions reduction targets for vehicles tied to local planning objectives
- this program is designed to assist local government in meeting these regulatory compliance objectives at the lowest possible cost
