## MATTERS OF INTEREST TO COUNCILMEMBERS/FUTURE AGENDA ITEMS

Councilmember Calvert asked for an update on the next agenda regarding the garbage cans at the park and ride on Horseshoe Bar Road.

Brian Fragio, Town Engineer/Public Works Director, stated he sent Councilmember Calvert the email from Caltrans stating that they don't allow garbage cans at the park and ride.

Councilmember Ucovich asked to have the study on Heritage Park put on a future agenda.

Cindy Walden, 3467 Humphrey Road, noticed that they are updating the Floodplain Management Ordinance and asked what that would involve.

Rick Angelocci, Town Manager, pointed out that this item is not on the agenda to be discussed and suggested contacting our Town Engineer for an update on that item.

8. **Housing Element Update**  
Each governing body of a local government in California is required to adopt a comprehensive, long-term General Plan for the physical development of the city. The Housing Element is one of the seven mandated elements of the local General Plan. Sacramento Area Council of Governments (SACOG) has offered to help issue an RFP for a consultant for the Town of Loomis to update the 2010 Draft Housing Element for submittal in February 2014.  
**Recommendation:** 1) Approve the Memorandum of Understanding between the Town of Loomis and SACOG for the hiring of a consultant to develop housing elements for the Town of Loomis and the City of Isleton; and 2) authorize the Town Manager to reimburse SACOG in an amount not to exceed \$25,000 for the consultant services from the budgeted Planning Contract funds.  
**Public comment:**

Jean Wilson, 4301 Barton Road, stated the following:  
- the Planning Commission worked with Lisa Wise, who was thorough and explained things very well  
- she questioned if all the work that was done before could be used to build on  
- the planning commission came up with different properties to consider for higher density  
- she recalls that the Village was assumed to take care of the numbers so nothing more happened

Following further discussion on the matter, a motion was made to approve the Memorandum of Understanding between the Town of Loomis and SACOG for the hiring of a consultant to develop housing elements for the Town of Loomis and authorize the Town Manager to reimburse SACOG in an amount not to exceed \$25,000 for the consultant services from the budgeted Planning Contract funds. On motion by Councilmember Ucovich, seconded by Councilmember Calvert and passed by voice vote.
