Termination of Local Emergency Declared March 19, 2020

Recommendation

Staff recommends the Town Council adopt the attached resolution terminating the Director of Emergency Services' Proclamation of a Local Emergency for the COVID-19 public health emergency, that was originally proclaimed March 17, 2020 and ratified by Council on March 31, 2020.

Issue Statement and Discussion

At the March 31, 2020 special Council meeting, Council affirmed the Town of Loomis Director of Emergency Services' proclamation of a local emergency, which was originally declared March 17, 2020. Council has reaffirmed that proclamation roughly every 60 days since.

Government Code section 8630 requires that the Town Council review the need to continue the local emergency at least once every 60 days until the Council opts to terminate the local emergency. State law also requires the Town Council to proclaim the termination of a local emergency as soon as conditions warrant. The Town Council last considered and continued the local emergency on April 13, 2021.

It should be noted that Rocklin dropped its declaration of local emergency on June 22, 2021. Placer County was to consider dropping its declaration on July 6, 2021. The other cities in the County (except for Colfax, who never adopted an order) will likely follow.

RESOLUTION NO. 21 - ___

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LOOMIS PROCLAIMING THE TERMINATION OF A LOCAL EMERGENCY

WHEREAS, on March 17, 2020, the Town of Loomis' Director of Emergency Services issued a Proclamation declaring the existence of a local emergency, finding that conditions of extreme peril to the safety of persons and property within the Town of Loomis were caused by the threat of COVID-19; and

WHEREAS, said Proclamation was ratified by the Town Council of the Town of Loomis on March 31, 2020,; and

WHEREAS, the Town Council of the Town of Loomis reviewed the need for continuing the local emergency at least once every 60 days thereafter as required by Government Code section 8630(c); and

WHEREAS, the situation resulting from said conditions of extreme peril is now deemed to be within the control of the normal protective services, personnel, equipment and facilities of and within the Town of Loomis.

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Loomis does hereby proclaim the termination of said local emergency.
