**3. CONCEPTUAL PUBLIC REVIEW FOR VERIZON WIRELESS “ENGLISH COLONY” CELL TOWER**

Verizon Wireless/Epic Wireless requests consideration of an 82-foot tall stealth water tower at 3170 Enterprise Court (APN: 043-015-029). The intent of the stealth water tower is to house antennas with an equipment shelter 11.5 feet by 16 feet, 10.5 inches. Verizon Wireless is proposing that the requested tower will match the color provided in the photosimulations. The requested tower is not located within one of these five allowable locations; therefore, staff is seeking direction from the Planning Commission.

**RECOMMENDATION:** That the Planning Commission review the application for Conceptual Public Review, ask questions of staff and/or the applicant, take public testimony, and consider future Planning Application for the proposed tower .

 Mitch Goodkin – 5811 Lawnview Ave – Discussed the need for a cell tower in area.

The Applicant Epic Wireless (Jacob Reeves) reviewed the concept of the Water Tower vs other options available for a Verizon Cell Tower in the Enterprise Court area in Loomis and led a question and answer session with the Planning Commissioners. The consensus of the Commissioners following the discussion was that they prefer the applicant co-locate a new tower on an existing tower in the area.
