PUBLIC HEARING

3. PROJECT #13-09 T-MOBILE CELL TOWER #SC74101A USE PERMIT (UP), VARIANCE (VAR), AND NEGATIVE DECLARATION

(A MODIFICATION TO #01-08 CINGULAR WIRELESS ANTENNAE FACILITY #SA-955-01 CUP) 5475 ROCKLIN ROAD, PCWA WATER TANK SITE, APN 045-161-019 & -022

The project consists of the modification of a previously approved Conditional Use Permit (CUP) for the construction and operation of a telecommunications facility. The modifications include: removal of antenna panels from PCWA tank; construction of a 45-foot tall monopole on a new \pm 65- square foot concrete pad adjacent to a leased, fenced equipment yard; relocation and installation of new 8-foot chain link fence sections to secure water tank; and, designation of a walking path for technician access to equipment yard. A variance to the 35-foot limit in the RE zone district is requested in order to construct the 45-foot tall monopole. A Negative Declaration has been prepared and circulated under CEQA. A No Effect Determination (NED) has been approved and issued by the California Department of Fish and Wildlife.

RECOMMENDATION: Hear staff report, take public comment, discuss and approve Resolution #13-06 for a Negative Declaration, Use Permit and Variance with the findings in Exhibit A and the conditions in Exhibit B.

PUBLIC COMMENT:

Tim Miller, speaker for the applicant, described the project

Chairman Hogan distributed and read the following letters:

(letter) Bill and Penny Loscotoff, 5305 Poppy Ridge, opposed to the cell tower:

- the existing water tower and proposed pole are an eyesore
- it is an unfair burden to the residents in the area

(letter) John and Inger Barakat, 5345 Poppy Ridge, opposed to the tower:

- potential health issues
- it is an eyesore
- building the tower is against the Town's strict policies regarding such development

Gary Liss, 4395 Gold Trail, asked the following questions:

- will this improve telecommunications in the area?
- can the pole be camouflaged better than as a brown pole?

John Barakat, 5345 Poppy Ridge Court, restated the following:

- there are potential health problems caused by cell towers
- would like it placed in a commercial area

Robert Barakat, 5335 Poppy Ridge, stated the following:

- there are health concerns with the placement of the tower in a residential area
- would like it placed in a non-residential area

Miquel Ucovich, 5911 Craig Court, stated the following:

- -the original tower did not require a variance to be placed on the water tower
- other spots in town are available to place tower
- there are potential negative health effects of microwave towers
- encouraged thorough research

Roger Smith, 6755 Wells Ave, stated the following:

- it is important to preserve the rural character of the area
- implored committee to look at options to camouflage the tower

Irene Smith, 6755 Wells Ave: Voiced her concern over potential danger to the water supply in the water tower

<u>John Barakat</u>, 5345 Poppy Ridge Court: Reiterated concern over potential health issues caused by telecommunication towers

Tim Miller, speaker for the applicant responded to public comment:

- Stated that since FCC regulations forbid using health concerns as reasons to oppose the placement of cell towers, he did not address those concerns in his introduction

Comments by the Commission:

<u>Commissioner Duncan</u> –clarified:

- -the panels on new tower are similar to the existing panels
- -this is the only tower serving the south side of town

Chairman Hogan - clarified that communication will only be slightly improved as a result of the new tower

Commissioner Wilson - clarified that the radiation levels will stay the same as the existing cells poles

Commissioner Baker -discussed future tree growth in reference to the tower's effectiveness

Commissioner Miller discussed the following:

- other cell sites in Town
- -the appearance of the pole

Mr. Miller (speaker for the applicant) -discussed the following:

- -color, appearance of the tower
- the cost of tree poles
- height requirement of tree pole- needs to be 8 to 10 feet taller than the proposed pole making the structure to be constructed about 53-55 feet tall
