PUBLIC HEARING:

3. PROPOSED ORDINANCE AMENDING CHAPTER 13.38.040, PROHIBITED SIGNS, OF THE LOOMIS MUNCIPAL CODE.

Recently, it has become more and more an issue with the parking of vehicles on private property fronting a public road where it is clear the intent is to advertise an off premise business or to sell the vehicle. Some of the vehicles advertise businesses not even located in Loomis as they were ticketed in the jurisdiction where the business is located and forced to move their vehicle signage to Loomis.

The current Code does not adequately address this issue. Although the code addresses the prohibition of permanent off premise signs, it does not adequately address the issue of vehicle off premise signs.

Commissioner Kelly asked for clarification on the scope of the ordinance

PUBLIC COMMENTS ON THE PROPOSED SIGN ORDINANCE AMENDMENT:

<u>Jackie Richardson</u> (Home) 7925 Rock Springs, Penryn (Work) 3432 Swetzer Rd # K Loomis – commented that the "green" truck is hers. Primary concern is attracting customers. At this time she is in violation of no current rules. Believes rules restricting off premise signs are a detrimental to her business success.

<u>David Emerson</u> – 466 C St Lincoln commented that small businesses are the essential to a town and leniency in signage should be explored <u>PCSO Deputy Bob Brodowsky</u> – commented that as the traffic deputy for Loomis the parking and signage ordinance as written have "no teeth" and therefore are very difficult to enforce. The amended ordinance makes it possible to enforce in a more universal manner.

COMMISSION DELIBERATION ON THE PROPOSED SIGN ORDINANCE:

Town Manager Rick Angelocci explained the history of signs on Swetzer Rd / Industrial Park

<u>Chairman Hogan</u> discussed the ongoing traffic issues on Swetzer Road and voiced support for those business owners who abide by the sign ordinance. Also discussed the need for universal enforcement.

Commissioner Onderko opened a discussion on how to support the small business owners in the Industrial Park area.

<u>Commissioner's Wilson and Onderko</u> both voiced their opinion that it is important that the ordinance is aggressively and uniformally enforced. <u>Commissioner Duncan</u> asked about advertising options and ideas for small businesses in town.
