#### **PUBLIC HEARING**

4. PROJECT #12-02 MUSCHETTO MINOR LAND DIVISION – 3330 BARKER ROAD, APN: 030-043-044 John & Ila Muschetto, the owners, are requesting a Minor Land Division approval on a ±9.25-acre parcel located at 3330 Barker Road. The request is to subdivide the ±9.25-acre parcel into two (2) parcels (Parcel A: ±4.61-acres, Parcel B: ±4.61-acres). The property is zoned "Residential Agricultural 4.6-acre lot minimum" (RA) and designated "Residential Agricultural 4.6-acres per dwelling unit" in the General Plan.

**RECOMMENDATION:** Hear staff report, take public comment, and approve Resolution #12-03 for a Minor Land Division to split a ±9.25-acre parcel into two (2) ±4.61-acre parcels at 3330 Barker Road (APN: 030-043-044) with the findings in Exhibit A and the recommended conditions in Exhibit B.

## **PUBLIC COMMENT:**

Staff gave a brief summary of the staff report/proposed project to the Commission and those in attendance.

<u>Bill Mitchell (applicant-Land Development Services)</u> - He explained the intent of the Muschetto's proposed project. He and his clients are okay with the proposed conditions of approval.

After a brief discussion, staff was directed to remove conditions #7 and condition #10 as both are repeat conditions. A motion to approve the proposed project (Resolution #12-03), with the removal of conditions 7 and 10, was made by Commissioner Wilson and seconded by Commissioner Bordelon and passed by a unanimous roll call vote (5-0).

# 5. AUDIENCE MEMBER STANDARDS OF CONDUCT AT PLANNING COMMISSION MEETINGS

Chairperson Thew has asked that the Planning Commission adopt a "Standards of Conduct" form and post in the meeting room. The "Standards of Conduct" form reminds audience members to act in an orderly manner, refrain from disrupting a meeting, using profanity or personal attacks, et cetera. <u>Gary Liss (4395 Gold Trail Way, Loomis)</u> - Said that he hopes the Town Council will consider adopting a similar form. He also indicated that clapping and cheering have been an issue at their recent Town Council meetings.

A motion to adopt and post (Depot) the "Standards of Conduct" form, with the Town Attorney's recommended changes, was made by Commissioner Bordelon and was seconded by Commissioner Thew and passed by a unanimous voice vote.
