Declaration of Certain Vehicles as Surplus and Authorizing their Sale at Auction

## **Recommendation**

Staff recommends that two (2) Town vehicles and one (1) piece of heavy equipment be declared surplus and disposed of via public auction.

### **Background and Discussion**

Town equipment from time to time is declared surplus due to age, cost of maintenance, reliability, or for some other relevant factor such as lack of use. The property is then removed from municipal service and sold at auction. The following vehicles and equipment are recommended to be declared surplus.

The two vehicles listed above are at the end of their useful life and would be costly to maintain in a manner that was reliable. The heavy equipment grader was purchased years ago when the town used to maintain gravel roads, but such maintenance is no longer performed, of is performed so infrequently that the equipment sits idle most of the time.

Section 3.12.150 of the Loomis Municipal Code grants the Town Manager the authority to sell supplies and equipment which are no longer used or have become obsolete or worn out. The code is silent on the disposal of vehicles, however. Given an estimated value for the grader of approximately \$20,000, the decision to surplus this piece of equipment and the two vehicles listed above are being brought before the Council as a recommendation.

## **CEQA Requirements**

There are no CEQA implications associated with the recommended action.

## Financial and/or Policy Implications

It is recommended that proceeds from the sale of surplus vehicles and equipment be credited to a Vehicle Replacement Fund, to be available for future vehicle purchases or replacements.
