10. WW Moulding 3800 Taylor Road Development Proposal Award

Staff re-released in June a Request for Proposals (RFP) for the redevelopment of the WW Moulding property, located at 3800 Taylor Road. The Town received one proposal, from Brian Nelson of Stargate Properties, LLC. Mr. Nelson proposes using the site for the creation of the Pine Star Brewery, Restaurant and entertainment Venue. The proposal notes that the site will be a "family-friendly destination location providing the Town of Loomis and surrounding communities a historically-rich culinary experience."

Recommendation

Staff recommends the Council award the exclusive development rights to the Townowned property at 3800 Taylor Road to Brian Nelson of Stargate Properties, LLC, pending completed purchase negotiations.

PUBLIC HEARING PROCEDURE:

- 1. Town staff makes its presentation on the Project and outlines all recommended actions
- 2. Commission/Council asks questions of staff
- 3. Chair/Mayor opens the public hearing
- 4. Applicant makes its presentation 15 minutes (At the discretion of the mayor or chair, time may be extended depending on the size/scope of the proposed project. The applicant must make the request for a time extension prior to the beginning of the meeting.)
- 5. Commission/Council asks questions of the applicant (and staff)
- 6. Public comment maximum 3 minutes per speaker, one opportunity to speak each
- 7. Applicant opportunity to respond to public comments 5 minutes (At the discretion of the mayor or chair, time may be extended depending on the number of comments made during public comment.)
- 8. Chair/Mayor closes the public hearing is closed
- 9. Staff responds to all public comments; Commission/Council asks any additional questions of staff
- 10. Council deliberates and acts on requested entitlements
