2. 3760 Bankhead Road – Request to change Land Use Designation from RE to RR

He also discussed traffic in the area Jean Wilson Asked again about the effect of SB9 on the parcels in the area before the sub-committee makes

any decision

Jon Cunnington. Spoke against any land use designation changes in the area

Miquel Ucovich – spoke on traffic and building types in the area and spoke against changing the land use designation.

Dave Dalli – Spoke against any rezoning or changing of land use in the area, wants Loomis to stay as it is Bonnie London – Spoke on the results of the last meeting regarding land use change requests and the ask about current traffic patterns in the area

Scott Toussaint – Spoke against the rezoning in the area.

3: Land use designation change from RE to RR (Requests # 5,6) Several parcels in the area – specifically called out 5140, & 5150 King Road and 3561 Bankhead. Note: The property owner at 5561 Bankhead withdrew the request prior to this meeting.

Jean Wilson – Spoke about well water availability in the area, and suggested caution if piped water is not available Scott Toussaint – voiced concern over changing the land use designation

Jean Wilson – Cautioned the committee of the responsibility to provide for "no net loss" if land use designation changes occur.

Dave Dalli- Stated that the Town should be flexible when a request is made for an ADU to provide for aging family member comes in.

Ryan DeMartini – suggested that the committee consider changing the land use designation of a limited number of parcels that run along King Road Road that do have access to water.
