RE: Mayor's Placer Mosquito and Vector Control District Appointment

Recommendation

Approve the Mayor's appointment of Russ Kelly to the Placer Mosquito and Vector Control District appointment for a term of four years, ending on January 1, 2026.

Issue Statement and Discussion

The Placer Mosquito and Vector Control District's seven-member Board of Directors are appointed for two- or four-year terms. Each city (and Town) appoints a member to the District, with most Directors serving for four years for continuity's sake.

The Town has, in the past, appointed its representative for a period of two years during the Mayor's committee appointment process (with the next Mayor affirming that appointment the next year). However, this process creates confusion and uncertainty for the District.

As a result, Staff recommends revising the appointment process for the Placer County Mosquito and Vector Control District to a four-year appointment, beginning with this upcoming appointment. Incoming Mayor Jennifer Knisley has indicated she would like to reappoint Russ Kelly to the District.
