MATTERS OF INTEREST TO COUNCILMEMBERS

Council Member Clark-Crets spoke on the importance role Japanese - American's played in Loomis history, asked for clarification that the council is referencing every February, not just February 2022 as Japanese - American History month.

Mayor Knisley thanked Ken Benedict for his role in establishing the Town of Loomis YouTube live streaming and recording of our Town Council and Planning Commission meetings.

TOWN MANAGER REPORT

Town Manager Sean Rabé discussed the following:

- COVID-19 has been spreading again throughout the community, and to better protect Staff and to provide for effective continuity of government, Town Hall will be moving to a minimum staffing level for at least the remainder of the month. Consistent with the State's recent mandate, we continue to require masks to be worn in Town Hall for all employees.
- Town Manager Tuesday's will remain on hiatus due to the surge in Covid cases, will return in February as the number of cases stabilize.
- The Loomis Library and Community Learning Center's plans for remembering the Japanese Internment during the month of February have been postponed at this time due to how COVID has proliferated in the community in the last month. The Library is working to create some virtual events instead.
- The Housing Inclusionary Ordinance will be brought to the Town Council at the February 8, 2022 Town Council Meeting.
- The Hidden Grove project has submitted application for initial review by staff. The review period to determine the completeness of the application ends on January 28, 2022. Town staff will send the review to the applicant, and the timing will resume when the applicant resubmits the completed application.

LOOMIS LIBRARY AND COMMUNITY LEARNING CENTER LIBRARIAN'S REPORT

Due to the recent surge in Covid cases, the "Month of Remembrance" events planned for Japanese History will be postponed until May. Throwback Thursdays will continue via Social Media during the month of February. The events scheduled for January will be postponed or cancelled. Origami club will resume as soon as it is deemed appropriate to do so. Storytime will continue outdoors on Fridays.

LOOMIS CHAMBER OF COMMERCE UPDATE

11. Creation of a Storm Water Fund with a Budget Equaling the Town's American Rescue Plan Act Allocation

On March 11, 2021, President Biden signed into law the American Rescue Plan Act (ARPA), in response to the Covid-19 pandemic, which allocated \$1,624,494 to the Town of Loomis. The use of these funds is limited to four categories of expenditure, one being making investments in water, sewer or broadband infrastructure. This category aligns with a large unmet need in Town in the form of storm water deficiencies and deferred maintenance. This, using an interpretation that sewer projects also included storm water. Should the ARPA funds be directed towards addressing these needs, staff will begin the process of prioritizing the work and categorizing them into bid packages for implementation

Recommended action: Staff recommends that the Town Council adopt a resolution creating a Storm Water Fund with a starting budget of \$1,624,494, representing the Town's full allocation from the American Rescue Plan Act (ARPA).

Public comment:

<u>Jesse Lunsford:</u> Stated and discussed his opinion that the funds we received through the American Rescue Plan be used to create senior housing

Pam Blake: Concurred with Jesse Lunsford on the needs for senior housing

Council comments:

<u>Councilmember Duncan</u> asked about future funding availability for broadband expansion purposes <u>Councilmember Clark-Crets</u> stated Jesse's comments are valid, and suggested that we hold off making a decision on these funds to a later date.

<u>Councilmember Brian Baker</u> asked about the defined purpose and use of the ARPA funds. Further stated that housing is not one of the listed approved uses of these funds, and he supports using the funds for a storm water fund.

<u>Councilmember Jeff Duncan</u> stated that he knows we need sewer and drain repair, but he doesn't think that this resource is appropriate to subsidize housing.

<u>Council member Cartwright</u> approves of the ARPA funds being used for Storm drain and sewer repair. The need is there and this an approved and appropriate use of the money. He is open for other ideas if there are funds remaining after storm water drainage systems are repaired.

<u>Mayor Knisley</u> stated she does not think that housing is an approved use of these funds, and has heard for years of the need to repair our aging drainage system. She is in favor of creating a Storm Water Fund with the ARPA funds allocated to the Town
