MATTERS OF INTEREST TO COUNCILMEMBERS Mayor Knisley addressed a concern she receive from a resident on Humphrey Road regarding a lack of a continuous sideway and the safety risk it presented. Mayor Knisley requested staff look into it.

Mayor Knisley also recognized Russ Kelley for his organization of the LOOMIS CARES community event that took place on March 31, 2022.

TOWN MANAGER REPORT

Town Manager Sean Rabé gave an update on the following items:

- The Town will sponsor Summer Swim days at Del Oro pool this year on Mondays and Fridays from 1 to
- Spring Clean up Day for Town of Loomis residents will be held at Del Oro High School from 8am to 3pm.
- The annual summer concert series returns this year. The concerts will be held the second Friday of each month (May 13; June 10; July 8 and August 12).
- Update on the Loomis Costco Project. The Town settled one of three lawsuits against the Costco project within a month of the project's approval. Rocklin has since appealed the Court's decision. Costco has cross-appealed that decision, as well as the Court's decision in the Citizens for Responsible

Growth case. In the meantime, staff has been processing the project's onsite improvement plans, which were submitted last month.

- Loomis Garage Construction continues on the project. Two out of the four units have confirmed tenants.
- The Hidden Grove The Town received the formal application in December 2021 the Town subsequently deemed the application incomplete. The Developer is now responding to the issues identified in the Town's review. Once that is done and the Town declares the application complete, the process will move forward.
- Town Manager Tuesdays are held the fourth Tuesday from 9 am to 10:30 am at the Loomis Train Depot.

LOOMIS LIBRARY AND COMMUNITY LEARNING CENTER LIBRARIAN'S REPORT

- The library has one now and will have three state park passes available for checkout.
- Storytime, Origami and the Spice clubs are up and running, with a large number of participants.
- April 23, 2022 the Library will hold Earth Day events
- April 29, 2022 the library will have a book sale.
- Plans in May will include the Month of Remembrance and the Garden Club will resume.

POSSIBLE DEDICATION OF LOOMIS DEPOT TRAIN DEPOT IRIS GARDEN TO HAZEL HINELINE 8. During the March 2022 Council meeting, Mayor Knisley asked to bring an agenda item before

the Council to consider dedicating the Iris Garden at the Train Depot to former Mayor Hazel

Hineline and authorize the commission of plaque in her memory

Mrs. Hineline served the Loomis community, in several different capacities, for many years. She was first elected to the Town Council in 1988, and again in 2000. She also served as Town Treasurer and served on the Planning Commission. She also served as the Executive Director of the Chamber of Commerce, and was instrumental in establishing the Iris Garden itself.

RECOMMENDED ACTION

Staff recommends the Council authorize the Town Manager to commission a plaque honoring former Mayor Hazel Hineline, with a not to exceed amount of \$800 and schedule a ceremony to dedicate the Iris Garden at the Train Depot in Hazel's honor. Hazel passed away February 14, 2022.

LOOMIS COSTCO PROJECT – Consideration of General Plan Text Changes 9.

General Plan and zoning code Text amendment for accessory uses - Addendum to the Environmental Impact Report Certification, General Plan and Zoning Code amendments, and Conditional use Permit

To approve the Loomis Costco Project through the following actions:

- Certify the Addendum to the Loomis Costco Environmental Impact Report (EIR), and 1. adopt the Findings as per the California Environmental Quality Act (CEQA);
- Amend the Town of Loomis General Plan; 2.
- Amend to Town of Loomis Zoning Code; and 3.
- Approve a Conditional Use Permit and design review for a warehouse retail use with an 4. accessory fueling station, subject to the conditions of approval.

RECOMMENDATION:

- 1. Conduct a public hearing and receive public input on the proposed Addendum to the Loomis Costco Environmental Impact Report, General Plan and Zoning Code amendments, and Conditional Use Permit;
- 2. Adopt the following resolutions and ordinance:
 - a. Resolution **22-09** adopting the CEQA findings and certifying the Addendum to the EIR;
 - b. Resolution **22-10** approving the General Plan Amendment;
 - c. Ordinance 290 repealing Ordinance 285 and adopting the Zoning Code Amendment; and
 - d. Resolution **22-11** approving the Conditional Use Permit, subject to the findings and conditions of approval.

PUBLIC COMMENT

<u>Frank Banuelos – Hunter Drive:</u> In favor of Costco and the location as long as walls are erected and homeless are kept out of the lot so that encampments do not develop. Rodent control during construction is also critical.

<u>Lorraine Thiebald – Los Flores:</u> In favor of the amendments and CUP for Costco. Recommends the Town works with Placer transit to extend transit service from Downtown to Costco. Recommends shade trees or solar panels in the parking lot.
