**5. GENERAL PLAN AMENDMENT TO THE PUBLIC HEALTH AND SAFETY ELEMENT – PLACER COUNTY 2021 LOCAL HAZARD MITIGATION PLAN (LHMP) UPDATE**

This project is a General Plan Amendment to update the Public Health and Safety Element of the General Plan to incorporate by reference the Placer County 2021 Local Hazard Mitigation Plan (LHMP) update consistent with the requirements of Disaster Mitigation Act of 2000 (DMA-2000), which requires local governments to update their LHMP every five years to be eligible for future federal disaster mitigation funding.

Adoption of the LHMP does not constitute the approval of a project under the California Environmental Quality Act (CEQA) and it is considered exempt from CEQA (Public Resources Code sections 15060 (c)(2) and 15061 (b)(3).)

**RECOMMENDATION:**

1. Conduct a public hearing and receive public input on the proposed amendment to the Public Health and Safety Element of the Loomis General Plan;
2. Adopt Resolution #22-\*\* recommending Town Council approval of the Placer County Local Hazard Mitigation Plan (LHMP) update and approval of an amendment to the Loomis General Plan Public Health and Safety Element to incorporate by reference the Placer County 2021 LHMP Update.

**6. #21-04 – LOOMIS RV CAMPGROUND – CONTINUED FROM APRIL 5, 2022  
5847 BRACE ROAD (APN 044-150-047), LOOMIS, CA 95650 (3.4 +/- ACRES) – TYALOR FAMILY TRUST**

Application #21-04 proposes construction and operation of a 34-space Recreational Vehicle (RV) Campground with an existing/vacant manager's quarters within the Tourist Destination Commercial and Tourist/Destination Commercial zone with an approved Use Permit. The new property improvements meet all Design Review components for approval.

At the direction of the Planning Commission at their meeting of April 5, 2022, staff was directed to prepare responses to public comments received and prepare an Initial Study to determine the appropriate environmental document for the project. Staff is currently finalizing the Initial Study and anticipates this matter to return to the Commission for consideration at the next meeting of June 28, 2022.
