### **RECOMMENDATION**

### **ISSUE STATEMENT**

On May 19, 2022 the Town Council of the Town of Loomis approved Resolution # 22-17 declaring an election be held in its jurisdiction; requesting the Board of Supervisors to consolidate this election with any other election conducted on said date; and requesting election services by the County Clerk.

On Tuesday, November 8, 2022, the General Election was conducted by the Placer County Registrar of Voters. The County Clerk's official canvass of the Election has been completed. Stephanie Youngblood, David Ring and Amanda Cortez were elected to serve full, four-year terms of office as Town of Loomis Councilmembers.

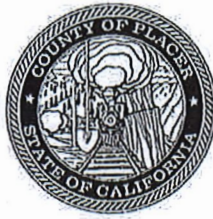


