



Get ready for California's next phase of **Mandatory MULTI-FAMILY HOUSING ORGANICS RECYCLING**

AB 1826 was signed into law in September 2014 and requires Multi-family housing complexes in California to recycle certain organic waste which includes green waste, landscaping and pruning waste, and non-hazardous wood waste. The law took effect in April 2016 and included phased implementation dates based on the amount of organic waste generated each week. Multi-family housing complexes generating four (4) or more cubic yards of solid waste per week will be required to separate their garden and landscape wastes from other waste for recycling starting January 1, 2019. Based on information from your hauler, Recology Auburn Placer (Recology), we believe your business should be recycling organics waste at this time.

Get Ready for California's next phase of Mandatory MULTI-FAMILY HOUSING ORGANICS RECYCLING

The requirement to recycle organic waste can be met by taking one or any combination of the following actions:

1. Recycle organic waste on-site.
2. Self-haul green and/or wood waste to Western Placer Materials Recovery Facility and require landscape contractors to do the same as part of your agreement.

Assembly Bill 1826 allows jurisdictions to, on a case by case basis, grant exemptions from these requirements to businesses that meet any of the following criteria:

- A. The business lacks sufficient space to provide additional organic material recycling bins.
- B. The business generates less than 1/2 cubic yard of organic waste each week.
- C. The business currently implements actions that result in the recycling of a significant portion of the generated organic waste.
