BRIEF DESCRIPTION OF THE PROJECT:

The Town of Loomis is proposing to widen a segment of Sierra College Boulevard between Brace Road and Taylor Road from four lanes to six lanes and to construct sidewalks and bicycle lanes along Sierra College Boulevard. A Draft Initial Study/Mitigated Negative Declaration (IS/MND) (SCH#2019129052) was prepared and circulated for public review from December 16, 2019 through January 17, 2020. Comments were received from the California Department of Transportation, the California Department of Toxic Substances Control, and the Central Valley Regional Water Quality Control Board. These comments included information and direction on applicable standard specifications and permit requirements for project design and construction and resulted in no revisions to the Draft IS/MND or the mitigation measures contained therein.

NOTICE IS ALSO GIVEN pursuant to Government Code Section 65009(B), that administrative remedies must be exhausted prior to anything initiated by you in a court of law. If you challenge the proposed project described above in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this Notice, or in written correspondence delivered to the Town at, or prior to, the Public Hearing.
