**NOTICE INVITING BIDS**  
Magnolia Street Storm Drain Replacement Project

**INSTRUCTION FOR SUBMITTING BIDS**

The Town of Loomis is soliciting bids from qualified Contractors to complete the project described herein.

1. **Qualifications:** Contractor shall possess a valid **Class A (General Engineering)**, California Contractor's license and a Town business license at the time the contract is awarded.
2. **Project Description:** Work generally includes the open-trench replacement of a failed, 12-inch corrugated metal pipe with a new 24-inch HDPE pipe, along with the construction of two manholes and an outlet structure over a distance of 250-feet. Work is on private property, within a side-yard storm drain easement, under a temporary right of entry obtained by the Town.
3. **Cost Estimate and Duration:** The estimated cost for the work is roughly \$100,000. The project duration, excluding the time for material procurement, is 10 working days. The Town anticipates awarding the contract at the March 14, 2023, Council meeting.
4. **Bid Package:** Plans and specifications are available free of charge. A copy can be obtained from the Town's website <https://loomis.ca.gov/bids-and-rfps/> or by e-mailing a request to the Town Engineer at the email address below.
5. **Pre-Bid Meeting:** Since work will occur on private property, the property owners have agreed to allow potential bidders to visit the site prior to the bid opening, A non-mandatory pre-bid meeting has been scheduled for Wednesday, February 22, 2023, at 9:00am, starting in front of 3755 Magnolia Street.

7. **Prevailing Wage:** As a "Public Works" project and pursuant to Section 1773 of the Labor Code, the general prevailing wage rates for Placer County shall apply to this contract.
8. **Reply Format:** All forms in the "Bid Proposal" Section shall be completed and returned to the Town Clerk at the Loomis Town Hall, 3665 Taylor Road, Loomis, California, by the bid's due date. Bids are required for the entire work described herein.
9. **Bids Due: 10:00 a.m., Thursday, March 2, 2023**
10. **Bidder's Security:** Bids must be accompanied by a proposal guarantee amounting to ten percent (10%) of the total bid as described in the specifications. Said guarantee shall be forfeited to the Town in case the bidder depositing the same does not, within seven calendar days after written notice that the contract has been awarded to him (1) enter into a contract with the Town and (2) furnish Performance and Payment Bonds and the required Insurance, as described in the specifications.
11. **Bid Award:** The bid will be awarded to the lowest responsible bidder at the discretion of the Town Council. The Town reserves the right to reject any and all bids, or to waive any errors, discrepancies or irregularities.
12. **Firm Prices:** All bid prices will be held firm for a minimum of sixty (60) calendar days after the due date for submitting bids.
