**TO:** Honorable Mayor and Members of the Town Council

RE: Accept 2022 Slurry Seal Project

### **Recommendation**

Staff recommends that the Town Council adopt a Resolution accepting the 2022 Slurry Seal Project completed by Pavement Coatings Co. and directing the Town Clerk to file a Notice of Completion with the Placer County Recorder's Office.

### **Issue Statement and Discussion**

On September 13, 2022, the Town Council authorized the award of contract for the 2022 Slurry Seal Project to the lowest responsive and responsible bidder with a construction budget that included contingencies of \$500,000.

Following the bid opening, the low bidder was determined to be the Pavement Coatings Company of Jurupa Valley, California. The Town entered into a contract with Pavement Coatings in the amount of \$384,175.35.

During the project, the Town initiated project change orders amounting to \$41,435.03 which included modifying the mix design to include less sand and replacing the emulsion to match that of a microsurfacing treatment. This gave a slightly thicker layer of seal coat that will last longer than the specified slurry seal. Some additional streets were also added into the project that were appropriate for a slurry seal but had not been included as part of the initial project scope. These additional streets, along with the original streets are summarized in Attachment B. There was also some minor tree pruning work that had to be completed ahead of the resurfacing, to allow for proper equipment clearance.

#### **CEQA Requirements**

The project was exempt from CEQA under Section 15301(c), maintenance of street facilities that do not create additional lanes.

## Financial and/or Policy Implications

The project was completed in the amount of \$425,610.38, which was within the construction budget of \$500,000.

**NOW, THEREFORE, BE IT RESOLVED** that the Town Council of the Town of Loomis does hereby accept the 2022 Slurry Seal Project improvements as complete; and be it

**FURTHER RESOLVED** that the Town Clerk is authorized and hereby directed to record a Notice of Completion with the Placer County Recorder's Office.
