Recycling of Construction and Demolition (C & D) materials is required for the following types of projects:

- All New Construction (residential and non-residential); and
- Residential additions/alterations that increase the building's conditioned area, volume or size; and
- Non-residential building additions greater than 1,000 square feet and/or Non-residential alterations valued at \$200,000 or more.

How to comply:

- 1. Decide how construction and demolition materials will be managed: 1) Hauled by Recology Auburn Placer (Recology), the Town's franchise waste hauler, or 2) self-haul.
- 2. Complete and submit this Construction & Demolition Recycling Diversion Plan form prior to building permit issuance.
- 3. During demolition and construction, haul debris as specified on this form and collect the required documentation listed in the table below.
- 4. Upon completion of construction and before final inspection, complete and submit the Construction & Demolition/Waste Management Summary Report form (Post Construction) along with all required documentation.
