## C&D Waste Recycling Requirements

On June 13, 2023, the Town of Loomis Town Council adopted Ordinance #293 effective July 13, 2023.

### What is Required?

All covered projects must divert 65% of construction and demolition (C&D) waste generated by the project.

#### **Recyclable C&D waste includes, but is not limited to:**

- Wood
- Concrete
- Dirt, sand, rock, and gravel
- Bricks
- Plaster
- Gypsum wallboard
- Aluminum and steel
- Glass
- Asphalt materials
- Plastics
- Roofing material
- Cardboard
- Carpeting
- Electrical wire
- Plant debris/trees

### Who Must Comply?

#### **Covered projects include:**

- All new construction (residential and non-residential).
- Residential additions/alterations that increase the building's conditioned area, volume, or size.
- Non-residential additions greater than 1,000 square feet and/or non-residential alterations valued at \$200,000 or more.

### How to Comply

1. Decide how construction and demolition materials will be managed: A) Recology Auburn Placer (the Town's franchise waste hauler) or B) self-haul.
2. Complete and submit a C&D Diversion Plan (form will be provided to you) prior to building permit issuance demonstrating how a 65% diversion rate will be achieved.
3. During demolition and construction, haul debris and collect the required documentation (listed on the next page).
4. Upon completion of construction and before final inspection, complete and submit the Waste Management Summary Report (a form will be provided to you), providing proof of actual recycling results including submission of tonnage receipts (weight tickets) to demonstrate the 65% diversion rate.

### Option A: Recology Auburn Placer

1. Order a bin or roll-off container from Recology Auburn Placer. To reach 65% diversion, you will need to source separate some materials into multiple bins (e.g., separate bins for concrete, wood, etc.).
2. **Collect all invoices and receipts** from Recology Auburn Placer.
3. Submit copies of all invoices and receipts with the Waste Management Summary Report (disposal facility weight tags and receipts).

### Option B: Self-Haul

1. You must recycle at least 65% of all construction and demolition waste generated.
2. **Collect all weight tags and receipts** from disposal facilities.
3. Submit copies of all weight tags and receipts with the Waste Management Summary Report.
