TO: Honorable Mayor and Members of the Town Council

RE: Accept Concrete Repair Project #22-04

Recommendation

Staff recommends that the Town Council adopt a Resolution to accept the improvements completed by Kroeker, Inc. for the Concrete Repair Project; file a Notice of Completion with the Placer County Recorder's Office; and authorize an additional appropriation in the amount of \$33,831.28.

Issue Statement and Discussion

On September 13, 2022, the Town Council awarded the Concrete Repair Project to Kroeker, Inc for their base bid amount of \$266,603, and authorized the expenditure of a construction budget with contingencies in the amount of \$300,000. The scope of work on the project involved removing and replacing displaced and damaged concrete in the public right of way, at various locations in Town, following a townwide survey of needs. Work also included the installation of a new concrete curb, gutter and sidewalk on Webb Street at Taylor Road, and the correction of a drainage problem with revised grades, new curb, gutter and sidewalk, and new asphalt paving at the intersection of Horseshoe Bar Road and Taylor Road.

On February 14, 2023, the Town Council authorized an additional budget appropriation of \$60,000 to complete concrete pathway and drainage gutter repair work in Sunrise Loomis Park that had been identified as part of a Proposition 68 State Parks grant application. This brought the total construction budget to \$360,000.

Over the course of the project, minor work scope additions were made, increasing the project quantities at the bid unit prices, to address additional concrete repair work that was discovered. There was also some unforeseen work, not identified on the bid schedule, that had to be completed by change order. This included the completion of additional conform grinding, installation of a trench drain to accommodate a rolled curb on Eldon Avenue, rerouting of existing electrical loop detector wires to terminate in a traffic box, and completion of additional asphalt paving to accommodate extended conforms behind the sidewalk at two commercial driveways.

In total, the extra work on the project resulted in costs that exceeded the construction budget by \$33,831.28. All work has now been completed, in the total amount of \$393,831.28.

CEQA Requirements

There are no CEQA implications associated with the recommended action.

Financial and/or Policy Implications

Funding for the \$33,831.28 in additional project expenditures is available for appropriation from the Public Works Transportation Fund (Fund 220).

WHEREAS, on February 14, 2023, the Town Council authorized an additional budget appropriation of \$60,000 to complete concrete pathway and drainage gutter repair work in Sunrise Loomis Park, bringing the total construction budget to \$360,000; and

WHEREAS, Kroeker has successfully completed the project improvements in accordance with the plans and specifications and to the satisfaction of the Town Engineer; and

WHEREAS, during construction, additional work was authorized by change order in an amount that exceeded the construction budget by \$33,831.28; and

WHEREAS, an additional appropriation in the amount of \$33,831.28 is needed to close out the project and there are sufficient funds in the Transportation Fund to cover the additional appropriation.

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Loomis does hereby accept the Concrete Repair Project as complete; and be it

FURTHER RESOLVED that the Town Clerk is authorized and herby directed to record a Notice of Completion with the Placer County Recorder's Office; and be it

FURTHER RESOLVED that the Town Council of the Town of Loomis hereby appropriates \$33,831.28 to the Concrete Repair Project from the Transportation Fund (Fund 220).
