## **Staff Updates**

Cristy reported on the following:

- The work that is being done on the Parks and Recreations Master Plan will include a community resident survey. This survey, when constructed, will be available from the Lowell City website, Facebook Page, and at a booth at Festival at the Park. Focus groups that include community members will also be involved in the contributing to the Master Plan.
- Representative from the Carolina Thread Trail have met with residents of River Falls to discuss the extension of the Thread Trail that would include their neighborhood. The individuals from the Carolina Thread Trail will also be meeting with residents of River View with similar discussions.
- The mobile mammogram bus will be in Lowell on Oct. 22<sup>nd</sup>.
- Citizens Academy continues. This ten-week course is available to the public and provides an in-depth view of all City of Lowell operations. The next meeting is Oct. 25<sup>th</sup>.
- Treat Walk will be on October 28th at 4:00pm.
- Music in the Park has been rescheduled for Nov. 6th.
- The city has been collaborating with the McCord family regarding the property across from City Hall. A possible rendering of the McCord Family Park was shared with the LCC. The vision for the park may include small concerts, pop-up yoga, library readings / events, lunch series events, food trucks, and other special events.
