# STORMWATER SPOTLIGHT: VEHICLE MAINTAINENCE

Stormwater runoff is simply rainwater that does not soak into the ground, but runs off hard surfaces like paved streets, parking lots, sidewalks and rooftops. As stormwater travels, it can pick up pollutants along the way. This stormwater pollution enters our waterways and can be detrimental to water quality and aquatic life. The storm drainage system in Lowell is a network of storm drain inlets and underground pipes that carry stormwater from our streets directly to our streams.

Fluid spills and improper disposal of materials such as oil, grease, antifreeze, etc. during or after common maintenance shop activities may result in pollutants, heavy metals and toxic materials entering our waterways through the storm drain system, creating public health and environmental risks. For this reason, it is important to understand the ways in which the vehicle maintenance industry can aid in keeping our waterways clean through the following Best Management Practices (BMPs). BMPs are methods or activities that may help prevent stormwater pollution.



**VEHICLE MAINTAINENCE BMPs** 

- Designate wash pads or servic bays away from storm drains for engine, parts, or radiator cleaning.

- Do not wash or rinse parts outdoors.

- Connect shop floor drains to a pre-treatment system that removes grit and oil & grease before discharging to the sanitary sewer system.

- Never discharge cleaning solutions used for engines or parts into the storm drain, parking lot or street.

- Routinely inspect vehicles and equipment for leaks, including all vehicles entering the service area.

- Tightly contain and cover all solid and liquid wastes.

- Store antifreeze, oil and other chemicalcontainers within a confined area specifically designed for storing hazardous materials, such as a tank or drum.

- Use non toxic solvents whenever feasible.

- Regularly pick up litter and clear off storm drains on your property.

- Recycle used oil, oil filters, grease, antifreeze, etc., as well as car tires and batteries.

-Inquire about rules and regulations for pretreatment systems within the City of Lowell.

### **OUARTERLY BULK PICK UP INFORMATION**

Lowell provides quarterly curbside collection at residential homes of items that are too large, heavy or bulky to fit in the City garbage cart for normal garbage pickup. Please keep in mind this program is intended for pick-up of customary residential items and is not intended for removal of commercial/contractor items or remnant items from home renovation projects. There will be no brush collection during Bulk Pickup Week.

4 times a year the City will pick up bulk items.

Schedule of Bulk Pickup (4 times per year)

-Your 1st collection day of March (\*beginning 2022)

-Your 1st collection day of June (beginning 2021)

-Your 1st collection day of September (beginning 2021)

-Your 1st collection day of December (beginning 2021)

Bulk items may be placed at the curb any time after 5 p.m. the day before your normal trash pickup day so long as they are out by 6:30 a.m. on your pickup day. Items that are placed at the curb outside of this time frame will be subject to a \$100.00 solid waste fine.

- Please DO NOT mix these items with limbs, leaves, or grass.
- Please DO NOT place any items in the street.
- Please DO NOT obstruct the sidewalk with items.
- Please DO NOT place these items on top of water meters or utility boxes.

Place items behind the curb and away from trees, parked vehicles, mailboxes or other obstructions.

Furniture: The City of Lowell will collect chairs, beds, mattresses and springs, sofas, bedroom/household furniture, and patio furniture.

Other Items: Disassembled swing sets, lawn mowers (drained of gas / oil), bikes, bagged trash, glass must be taped with the shape of a X (no windows), other bulky items.

E-Waste: Electronic waste is anything with a computer circuit board (cell phones, computers, radios, television, etc.). E-waste can be taken to all of the Gaston County Convenience/Recycling Centers. For more information, please call the Gaston County Recycling Hotline at (704) 922-7729.

Debris Resulting From Construction, Demolition or Repair: It shall be the duty of the property owner or contractor to dispose of debris resulting from the construction, remodeling, demolition, or repair of buildings. No material from land clearing will be picked up by the City.

The City does not pick up automobile parts, tires, batteries, paints and liquids, hazardous, toxic waste, or pool chemicals. This material must be taken to the Gaston County Landfill located in Dallas, NC.

Appliances: The City of Lowell does not collect appliances such as stoves, ovens, refrigerators, freezers, dishwashers, washers, dryers, air conditioners, trash compactors, and hot water heaters. North Carolina State Law now prohibits the dumping of appliances in landfills. This law also requires that businesses who sell appliances charge an appliance disposal fee to cover the cost of the appliance. Citizens are encouraged to allow the business selling the new appliance to dispose of the old one.

As a reminder, additional rollout carts can be ordered by calling City Hall. If you have more than a half pick-up truck load of debris that needs to be disposed of, you can request the use of the City's loaner dump truck. The City loaner truck is not to be filled with any debris from commercial contractors. You must have an active water account with us and a truck request form will need to be completed at City Hall.

## STORMWATER MANAGEMENT PLAN

The City of Lowell has a draft Stormwater Management Plan that is open for public comment now through February 28, 2021. For details, please visit: www.lowellnc.com/248/Stormwater-Management.

The National Pollutant Discharge Elimination System (NPDES) Municipal Separate Storm Sewer System (MS4) Program is mandated under the federal Clean Water Act. An NPDES MS4 permit is required for every MS4 owner or operator with jurisdiction in a U.S. Census Bureau designated Urbanized Area.

To obtain a NPDES permit for stormwater management, an applicant (i.e. the City of Lowell) shall develop, implement, and enforce a stormwater management plan approved by NCDEQ that satisfies the six "minimum control measures."

The City of Lowell has a MS4 Permit and because of that we must develop a Stormwater Management Plan (SWMP) to be monitored and approved by North Carolina Department of Environmental Quality that specifically addresses the following 6 minimum measures, often referred to as Best Management Practice (BMPs.)

The six minimum measures in the Lowell SWMP are:

- 1) Public Education and Outreach Program
- 2) Public Involvement and Participation Program
- 3) Illicit Discharge and Detection Program
- 4) Construction Site Runoff Control Program
- 5) Post-Construction Site Runoff Control Program
- 6) Pollution Prevention and Good Housekeeping Program
