#### GOOD NEIGHBOR POLICY

The Lucas Fire District stretches from Forest Grove Road on the North to Parker Road on the South, from FM 2551 on the West to Lake Lavon on the East for a total area of approximately 23 square miles. At the present time there are 27 firefighters within the department. During a major fire, manpower needs skyrocket and, especially during hot weather, the amount of time a firefighter can operate in extreme conditions is measured in minutes. The tasks associated with putting out a large fire are many, and take a toll on the strength and endurance of the members.

Due to these factors, Lucas VFD has an arrangement with Parker VFD to automatically assist on any fire calls. In a large city, the normal response to a "One Alarm" fire would be at least three engines, a ladder truck and one ambulance. Manpower assigned to a situation in the big city would be around 25 - 30 personnel. Depending on the time of day, the Lucas & Parker VFDs can put approximately 25 - 50 firefighters on the scene. Our two departments normally will respond with four engines and a manpower squad. Both departments are alerted by the Plano Dispatch Center, and with a simple keystroke are linked to the same radio frequency.

With such a close working relationship, both departments train together, usually on a monthly basis and know each other's capabilities and personnel. The officers of each department direct the scene through a recognized Incident Command system. During an emergency a bystander may see both department's officers working shoulder to shoulder.

Frequently there are needs for additional manpower or equipment and the call is then made to other neighboring departments. The Lucas VFD also works closely with Branch, Fairview, Wylie and Plano Fire Departments. Each of these groups has a unique niche that can be called upon in a time of need.

Of course Lucas VFD returns the favor and, in the event of a fire or manpower request, will respond to the City Of Parker with our resources. Because of foresight and planning, the cities of Lucas and Parker have doubled their firefighting capabilities. Owners of homes saved from total fire devastation in the recent past can attribute their situation to this arrangement.

During a major fire a citizen will observe many examples of neighbors helping neighbors, or in our case, departments helping departments, brothers helping brothers. Lucas City Newsletter November, 2006

#### **CITY WORKS**

If you have attended City Council or any Board or Commission meetings, you know that they follow a certain

pattern each time. What you may not know is that the manner in which meetings are announced and conducted is set forth under guidelines mandated by state law. The primary guidelines used were established by the "Open Meetings Act." The goal of this act was to require all government body meetings to be open and accessible to the public, except for expressly authorized executive sessions.

Any decisions that must be made by the governmental body must be made at a properly called meeting, and must be made by a quorum (majority) of the members of that body. This requirement is meant also to prevent members of the government body such as a city council from holding informal meetings "behind the public's back".

The law requires that the time, place, and subject matter of all meetings be posted at least 72 hours prior to the meeting in a readily accessible public place, such as City Hall.

Once the agenda has been set, members of the Council, Board, or Commission must follow that agenda. Although members of the public have no legal entitlement established by the Open Meetings Act to speak on any agenda items, our Council, Boards, and Commissions have established a precedent of including "Citizen Comments" sessions at the majority of their meetings. During these sessions, citizens are invited to speak out on not only any item on the agenda, but also on any other city matters that they wish to address. However, the members of the Council, Boards, or Commissions may not answer questions or engage in dialogue with speakers during this session. To do so could put them at risk of getting "off agenda", and thus potentially be in violation of the Open Meetings Act. The City does retain the right to set reasonable limits on the number, frequency, and length of presentations, but it may not unfairly discriminate among speakers for or against a certain point of view.

The Council, Board, or Commission may discuss a subject not listed on the agenda only as a proposal to place the subject on a future agenda. In a future column, we will discuss how agendas are set, and go through the various parts of the agenda in detail.
