# CORRECTION REGARDING FILING DEADLINE FOR COUNCIL SEAT 2

On **May 9, 2015** the City of Lucas will hold a General and Special Election. The positions that will be on the ballot are the Mayor, Council Seat 3, and Council Seat 4, all with terms expiring in May 2018. Additionally, a Special Election will be held to fill the unexpired term for Council Seat 2. Council Seat 2 became vacant as result of the current Councilmember resigning to run for the position of Mayor. The candidate elected to Seat 2 will serve for the unexpired term which is May 2017.

# Lucas receives an "A" in Transparency!

As reported in The Dallas Morning News

In a yearlong audit of open government compliance, The Dallas Morning News approached 113 local agencies to determine how well they followed state laws guaranteeing access to infor-

mation about how taxpayer money is spent and whether they followed best practices, such as those developed by the state Comptroller, in 2014. More than 1 in 5 local government entities assessed scored a "D" or an "F."

Lucas was among the best in the Transparency 2015 ratings. It ranked as excellent in request best practices, excellent in request compliance, poor in web customer service, and excellent in online meeting notices.

Please be aware that, in order for Congressman Johnson's staff to make inquiries on constituents' behalf, the Privacy Act of 1974 requires a privacy release be signed before the agency is contacted. If you are represented by counsel, their permission to assist with the case is also required. Make sure to bring all relevant documents so staff is able to help you as expediently as possible.

# City of Lucas Outdoor Burning Regulations



The steps you must take before initiating an on-site burning of trees, brush, grass, leaves, branch trimmings, or other plant growth have changed.

Starting in February 2015, instead of calling the Collin County Burn Information line, you will need to check the City of Lucas website first to determine if it is an authorized burn day. Burn Day alerts are shown in the black Alert banner at the top of the page. If it is an authorized burn day, you will first need to obtain a Burn Permit from the City of Lucas. Once you have been issued your burn permit, you will still need to call Plano Dispatch at 972-941-7100 and advise them that you are conducting an outdoor burn. They will record the same information as before (name, address, phone number, and current burn permit number).

Please note that <u>a burn permit is required</u> before burning begins. Burn permits are good for 30 days, cost \$10, and can be obtained at City Hall.

It is important to know and follow safety rules including staying with the fire until it is extinguished.

### Storm Water - A Lost Resource

One problem with not allowing rainfall to infiltrate the soil is a lowering of the level of the water that exists in the soil and rock below the ground surface - also known as the groundwater table. Water below the ground, or groundwater, slowly seeps into our streams over a long period of time. This is why many streams continue to flow even when it has not rained for a while. This flow keeps fish and other wildlife alive. If the infiltration of rain water into the ground is cut off by more and more impervious surfaces, the groundwater table can drop and streams can dry up. If the water table drops below the depth of a water supply well, the well can dry up.

The EPA has developed a strategy to promote the management of storm water as a valued water resource, to prevent pollution caused by storm water discharges, and to minimize the damaging effects to streams and public health. Included in the strategy is a new approach to storm water management known as low impact development. This approach has been used in urban and suburban areas for new development and to retrofit existing development. It is based on the concept of managing storm water on the site where it is generated, often by simple structures that allow the water to infiltrate the soil.

#### What can I do?

- Instead of directing the water from your drain spouts to your driveway, direct it to a rain barrel for later use, or to a grassy
  area, a french drain, an infiltration trench, or a shallow depression where the water can soak in.
- Mulch and plant a shallow depression or rain garden with some of the many attractive trees, shrubs, and plants that like "wet feet".
- If you already have a wet area on your property, don't fill it in consider it an asset!
- Instead of paths made of concrete, consider mulch, crushed stone, or other permeable paving materials.
- Reduce the amount of lawn area on your property by replacing it with trees and shrubs in a mulched bed.
- Add organic matter, like composted leaves and grass, to your soil. This will allow the soil to absorb and retain more rain and will benefit your plants also.
