Bobby Parr is one of the last few residents in Lucas that actually grew up here. Because of the pride he has for Lucas and simply because he's just a nice guy, he mows the frontage along Stinson Road for his neighbors. This may not seem like much until you consider that that frontage is about 5,934 feet and includes fifteen of his neighbor's properties. Bobby does not "get" anything for doing this but the satisfaction of being a good neighbor and the pride of beautifying our neighborhood. Please come by Stinson Road sometime and you'll see him out there with a big smile on his face waving hello to all the passersby. If you take a moment to stop and say hello, you can be sure that he'll have a humorous story to share!

I'd like to share a story about an experience I had before I knew Mr. Parr and turned out to be my introduction to knowing him. When I was new to the neighborhood I used to drag my push cart over to the McKamy farm to get their horse manure for my garden. One day the tire went flat on that old thing and I was telling Melvin McKamy about how I had looked everywhere for a tire that would fit it but could not find one. A few days later a tire appeared on my front porch that fit that old cart. I didn't know who could have it left since Melvin said that he had not. It made me wonder which of my generous neighbors would do such a thoughtful thing. That got me to thinking about how lucky I am to live in such a place where the people are so friendly and helpful that you are not sure who to thank. Yep, it was Bobby, someone had mentioned something to him and that was it. This is what it means to me to live in Lucas.

Deter, Detect & Defend Avoid ID Theft

I dentify theft is a serious crime. It occurs when your personal information is stolen and used without your knowledge to commit fraud or other crimes. Identify theft can cost you time and money. It can destroy your credit and ruin your good name.

Deter identify thieves by safeguarding your information. Shred financial documents and paperwork with personal information before you discard them.

Protect your Social Security number. Don't carry your Social Security card in your wallet or write your Social Security number on a check. Give it out only if absolutely necessary or ask to use another identifier.

Don't give out personal information on the phone, through the mail, or over the Internet unless you know who you are dealing with.

Never click on links sent in unsolicited emails; instead, type in a web address you know. Use firewalls, anti-spyware, and anti-virus software to protect your home computer; keep them up-to-date. Visit <u>www.OnguardOnline.gov</u> for more information.

Don't use an obvious password like your birth date, your mother's maiden name, or the last four digits of your Social Security number.

Keep your personal information in a secure place at home, especially if you have roommates, employ outside help, or are having work done in your house.

Detect suspicious activity by routinely monitoring your financial accounts and billing statements.

Be alert to signs that require immediate attention:

Bills that do not arrive as expected

Unexpected credit cards or account statements

Denials of credit for no apparent reason

Calls or letters about purchases you did not make

Inspect:

Your credit report. Credit reports contain information about you, including what accounts you have and your bill paying history.

The law requires that major nationwide consumer reporting companies – Equifax, Experian, and TransUnion – to give you a free copy of your credit report each year if you as for it.

Visit www.annualcreditreport.com or call 1-877-322-8228,

a service created by these three companies, to order your free credit reports each year. You can also write: Annual Credit Report Request Service, PO Box 105281, Atlanta, GA 30348-5281.

Your financial statements. Review financial accounts and billing statements regularly, looking for charges you did not make.

Defend against ID theft as soon as you suspect it.

Place a "Fraud Alert" on your credit reports, and review the reports carefully. The alert tells creditors to follow certain procedures before they open new accounts in your name or make changes to your existing accounts. The three nationwide consumer report companies have toll-free numbers for placing an initial 90-day fraud alert; a call to one company is sufficient:

TransUnion 1-800-680-7289

Equifax 1-800-525-6285

Experian 1-888-EXPERIAN (397-3742)

Placing a fraud alert entitles you to free copies of your credit reports. Look for inquiries from companies you haven't contacted, accounts you did not open, and debts on your accounts that you can't explain.

Close accounts. Close any accounts that have been tampered with or established fraudulently.

Call the security or fraud departments of each company where an account was opened and changed without your okay. Follow up in writing, with copies of supporting documents.

Use the ID Theft Affidavit at ftc.gov/idtheft to support your written statement.

Ask for verification that the disputed account has been closed and fraudulent debts discharged.

Keep copies of documents and records of your conversations about the theft.

File a police report. File a report with law enforcement officials to help you with creditors who may want proof of the crime.

Report the theft to the Federal Trade Commission. Your report helps law enforcement official across the count in their investigations.
