THOUGHTS FROM THE MAYOR

Many of you have heard by now that a plan is in the works to develop a new commercial/retail area in the area on the northeast corner of West Lucas Road and FM2551. You may have also heard that the major tenant of this development will be a Wal-Mart Super center. The following gives some background of this particular development:

A site plan was submitted and approved in 2006. As required by City ordinance, two public hearings were held, one in front of Planning & Zoning Commission on 9/11/06, (continued on 10/9/06), and the second one in front of City Council on 10/16/06. The site plan was approved by Council at that time. A preliminary plat was submitted in 2007 for a proposed retail development. This plat met all legal requirements and was approved by City Council on December 6, 2007. Preliminary plats, once approved, do not have to be resubmitted unless there are major changes to the development, or if no development has taken place by the end of 5 years after the filing of the plat. The developer is within the 5 year time frame.

The area of the proposed development is zoned CB (Commercial Business), and the preliminary plat was submitted and considered accordingly. As long as any prospective development meets all requirements set out in the ordinance regulating development within that zoning category, by law the plat must be approved. The plat must conform to the ordinances that were in effect as of the date of the submission of the site plan, and generally will not be affected by any ordinances subsequently passed. The preliminary plat that was submitted for this project met all legal requirements for the CB zoning category. The building and site plans and the final plat, when submitted, must also confirm to all legal requirements, such as lighting that meets our "dark sky" requirements, proper buffering and shielding from adjacent neighborhoods, and other regulations meant to minimize impact on neighbors.

Over the next weeks, it is anticipated that building plans and site plans will be submitted for review. Once the building plans are approved, they will receive a building permit to start construction. It is likely that, barring any unforeseen circumstances, construction should start this coming spring.

The City is working with the developer to encourage them to build out this site in a manner that will be consistent with the desired character of our City. It is our strong desire that any commercial establishment becomes a vital and contributing member of our community. A strong commercial district will generate a revenue stream that will help fund much needed improvements to our infrastructure without the necessity of drastic property tax increases.

Lucas Fire Department to conduct CERT Training

The Lucas Fire Department will be starting its fifth CERT training in January 2012. The training will be held on Wednesday evenings from 6:30 – 9:30 pm with one Saturday morning.

After a disaster citizens may be on their own for up to 72 hours until the first responders can reach them. The Community Emergency Response Team (CERT) program teaches citizens the skills they need to help themselves, families and neighbors until help can arrive. After completing the CERT training additional non-disaster opportunities and trainings will be available, some included, but is not limited to, helping the Lucas Fire Department with Disaster Preparedness events, Community Outreach and Events, Disaster Drills, Fire Rehabilitation training to help staff a fire rehabilitation unit to help the firefighters recuperate during large fires, ham radio communications, and fire safety/prevention. Collin County Lifts Burn Ban

As of October 28th Collin County has rescinded the burn ban. Due to the length of the burn ban there are quite a few very large stock piles of yard waste materials around the city. We would just like to remind everyone of a few of the cities basic rules to help prevent any mishaps that may occur due to the volume of some of the stock piles.

1. Open Burning is required to be a minimum of 300 feet from any structure Sec. 307.3.
2. Open burning is required to be constantly attended whenever there is open flame Sec 307.4.
3. Open burning requires a permit Sec. 307.2. Only the property owner may apply for an open burn permit.
4. Open burning has a limited size and amount. The size and amount is dictated by the amount necessary to become offensive or a fire hazard as a general rule the fires height should not exceed 5 feet and 10 feet across. Sec. 307.2.2 (use good common sense i.e. no fires 30 feet tall with smoke enveloping your neighbors)
5. No open burning after dark. (This does not include small bonfires or cook fires).
6. Contact Plano dispatch to determine if it is a burn day at (972)548-4799, ask for fire dispatch.
7. The hauling of material from another site is strictly prohibited.
8. The property owner is responsible for any and all damages caused by open burning.
