Development Corporations Under Consideration

The City Council of the City of Lucas is exploring the **L** idea of the creation of a Community Development Corporation, and an Economic Development Corporation utilizing the adoption of a 1% sales tax on taxable sales in Lucas. Many people ask about the difference between Community and Economic development, in basic terms, Community Development is the development of Parks, Infrastructure, and other amenities that make a community a nice place to live, while Economic Development is broadly defined as an effort that spurs economic growth in an area. Generally, the goal of economic development is to create more economic activity so that ultimately sales tax revenue will increase, reducing the reliance on the property taxes of a City. While Community Development focuses on adding to quality of life issues such as parks, fine arts, and community improvements that make a City attractive to future residents and businesses. If these two corporations are approved, there will be appointed volunteer boards to oversee the expenditures of the corporations to ensure

that these funds are spent in a manner pleasing to Lucas residents and in accordance with State law. Using current sales tax revenue it is estimated that these two corporations would collect approximately \$160,000 collectively on an annual basis. This amount would rise dramatically if retail development were to build on the outskirts of the community.
