Straight Talk from the Mayor



I want to thank our Lucas citizens for their outstanding participation in the recent runoff election for Council Seat 2. A large number of votes were cast (584). Considering that vacation season is upon us, with many families traveling out of town, this was a really good turnout. It was also

especially gratifying to see a large number of first time voters.

The recent election was a step in the transition to a Council comprised of six Councilmembers and a voting Mayor. Previously, there were five members, and the Mayor only voted in case of a tie. In the future, all terms of office will be for three years. Starting this year, the Mayor and the Councilmember for Seat 3 (Don Zriny) were elected for 3 year terms. Seats 1 (Mark Barratt) and 2 (Rebecca Mark) were elected for 2 year terms. In the next election for Seats 1 and 2, the seats will transition into 3 year terms. In 2010, Seats 5 and 6 will be elected for 3 year terms, and Seat 4 will be elected for a 2 year term. Starting in 2011, and continuing forward, all seats will be elected for 3 year terms.

The hardworking election judge and election clerks are also owed a special vote of thanks, as are the City Hall employees who handled early voting.

One election per year is a lot of work, and these great people handled two!

City of Lucas' Fire Department

The City of Lucas' Fire Department recently went through an Insurance Services Office (ISO) inspection. The goal of this inspection is to accurately reflect a community's fire suppression and control resources through the Public Protection Classification (PPC) system.

We are very pleased to inform the citizens that ISO has a recommended a two part classification for the City of Lucas' Fire Department, a 3 and a 3/9. First, anyone who lives within the city limits of Lucas will receive an ISO rating of three. This should equate to an estimated 12% to 13% savings on fire insurance rates for all Lucas citizens. The savings could vary with each insurance company. Second, for those who live in our ETJ and within 1,000 feet of a fire hydrant, will also receive a three. For those who live more than 1,000 feet from a fire hydrant, and outside the city limits, will receive a 9. This is a major accomplishment for our department. Many paid departments with million dollar budgets have not been able to accomplish this rating. As a comparison Coppell was a three for the past ten years operating with three fully staffed stations covering only 14 square miles. Last year Coppell did receive an ISO rating of one, and became one of only 54 departments nationwide with this rating.

Fire Chief Kitchens and the volunteer firemen wish to personally thank Mayor Bill Carmickle, Councilmembers Debbie Fisher, Don Zriny, Kathleen Peele Mark Barratt, Wayne Millsap and City Manager Robert Patrick for the dedicated support given the Lucas Fire department. This accomplishment would have never been possible without the support of our citizens and City Council.

WATER LINE CONSTRUCTION ON COUNTRY CLUB ROAD



The City has awarded a contract to Wilson Construction for the construction of water line improvements along Country Club Road. The

improvements will be replacing an existing 6 inch water line with a new 12 inch line from Blondy Jhune Road, to just north of Forest Grove Church. Another section will add a 16 inch line from the City water tanks on Country Club Road, south to Estelle Lane. All the work on Country Club Road will be in existing road right-of-way, on the east side of the road. Also, an 8 inch line will be added in Forest Grove Road, on the north shoulder, from Country Club Road, east approximately 900 feet to the 8 inch line installed by the Wolf Creek development. That section will upgrade the existing 6 inch line.

These improvements are part of the City's Water Master Plan, and will improve water service for current and future residents in the northwest section of the City.

The work is scheduled to begin in July and take approximately 6 months to complete. Residents will be notified prior to their service lines being connected to the new lines. There will be a brief interruption of water service at that time. There is also the possibility of unexpected interruptions of water service during construction.

Rebecca Mark Elected to Councilmember, Seat 2



Welcome Councilmember Rebecca Mark! The City of Lucas made history recently with the election of Rebecca Mark to Councilmember, Seat 2. The newly created seat has been vacant since the citizens voted to pass the Home Rule Charter in May 2008. On June 20, 2009 some 584 citizens of Lucas turned out to vote in the first ever Runoff Election held in the history of Lucas (17.5% of the registered voters for the City of Lucas).

The City Council wishes to thank the City Staff, the Election Judge, and the election workers for all the hard and efforts put forth in conducting this election.

Door-to-Door Solicitation Alert

The City of Lucas has received several complaints concerning door-to-door solicitation for driveway paving. These contractors claim to have "extra material" from a job they have just completed and will offer a price "good for today only". Though the complaints vary, generally the unsatisfied customer mentions the use of a product inferior to what they thought they were getting or the final cost greatly exceeding the total that was expected. Often intimidation is used and threats are made, including the threat of a lien on the property if the contractor's demands are not met.

Lucas requires a permit before any driveway paving on city road right-of-way is to begin. This is intended to protect the property owner from shoddy workmanship and unscrupulous contractors. Reputable contractors do not carry extra asphalt or other materials door-to-door. When a contract is made, the property owner should have sufficient time to review the agreement without fear of losing a good price.

To protect themselves, Lucas property owners should consider the following normal practices:

1. Get 3 or more bids before agreeing to a contract. The best way to find a good contractor is to

ask someone who has had the same work done and is a satisfied customer. The city maintains a list of contractors who have done work in the city as well as the number of the jobs they do.

Unsatisfactory contractors are not kept on the list.

- 2. Know the reasonable charges for the different materials. For chip seal work, this amount may vary from \$3.50/yd² for a large job (like a street) to \$10/yd² for small jobs (a typical 1 lane driveway and 2 or 3 parking spaces). For asphalt these amounts vary from \$10/yd² to \$14/yd². Concrete runs \$4.25/ft² to \$5.50/ft² (to convert this cost to square yards, multiply x 9)
- 3. Do not accept a business card with a dollar amount written on it. This written amount is construed to be the contract price regardless of the verbal agreement.
- 4. Have a signed contract with a completed job cost total (turn key) before allowing any work to begin.

If you suspect you are dealing with a disreputable contractor you may call the city, but the city can only issue a citation if the workers are still on the job and witnessed by the staff member. Remember, if the price offered seems too good to be true, it may not be what you are looking for. If you know of suspicious activities in your neighborhood call the city office at 972-727-8999.
