City Council Actions for May

- * Approved a request by KWIK Industries for a final site plan approval. The property to be considered is located in Collin County, Texas, and described as ABS A0821 William Snider Survey, Tract 32, 6.47± acres.
- * Approved Ordinance # 2013-05-00756 an amendment to the City of Lucas' Code of Ordinance, Chapter 14, Zoning, Article 14.03, Districts, Division 6 Village Center District (VC) Section 14.03.292 Use Regulations by adding (5) All drive-thrus, drive-ins, drive-ups require a Specific Use Permit (SUP); Division 7, Commercial Business District (CB) Section 14.03.352 Use Regulations by adding (12) All drive-thrus, drive-ins, drive-ups require a Specific Use Permit (SUP); Division 9, Light Industrial District (LI) Section 14.04.471 Use Regulations by adding (3) All drive-thrus, drive-ins, drive-ups require a Specific Use Permit (SUP).

Message From the Mayor


We are all pleased to report that HB 339 was passed by the Senate on May 20,2013. As you will recall, I have been writing about this important legislation since early this year.

This bill, once signed into law by Governor Perry, will allow the City of Lucas to let you, our voting residents, decide whether or not we should form a Fire and Emergency Services District that can be partially funded by designated sales taxes. Our current sales tax is only 7 3/4%, leaving another 1/2% that, with your approval, could be used to fund fire and emergency services for our City and the surrounding areas we serve. This means that all who shop in our Lucas businesses could help fund these services, rather than the entire cost being borne by City of Lucas property owners.

If signed by Governor Perry, the legislation will become effective Sept. 1 of this year. City Council can then put the proposition on the ballot for your consideration at the May, 2014 election.

We all owe a big thanks to State Rep. Jodie Laubenberg and her staff for all their hard work, as well as Sen. Ken Paxton and his staff.

Stage 3 Water Restrictions in effect June 1, 2013

Below average rainfall, low lake levels prompted NTMWD Board to implement Stage 3 of Drought Plan. On April 25th the board voted to initiate Stage 3 of the NTMWD Water Conservation and Drought Contingency and Water Emergency Response Plan effective June 1, 2013.

The goal of the Stage 3 restrictions is a 10% reduction in water use and increased awareness in ongoing water conservation efforts. Under Stage 3, residential and business customers will be limited to land-scape watering and sprinkler or irrigation systems once every seven (7) days.



Athletic Fields at Kenneth R. Lewis Community Park Closed for Maintenance June 1–July 15

The City of Lucas will close all athletic fields at the Kenneth R. Lewis Community Park beginning June 1st through July 15th for scheduled maintenance.

No reservations will be made during this period due to the possible use of heavy machinery and chemicals. During this time it will be unsafe for the fields to be used by teams so we ask for your cooperation by staying off the fields.
