

2008/2009 FISCAL YEAR BUDGET PLANNING

City Council and staff have been going through the process of drafting the fiscal year 2008/2009 budget to be effective October 1.

The first public hearing regarding the proposed ad valorem tax rate was held on August 21. The proposed rate of .374177 is a slight decrease from the 2007/2008 rate of .375. A second public hearing will be held on Sept. 4.

The first public hearing on the proposed Budget for the new fiscal year was also held on August 21, and the second public hearing will be on Sept. 4.

BURN BAN LIFTED

Due to last week's heavy rains, Collin County has lifted the outdoor burn ban that was previously imposed on July 22 due to the extremely dry conditions this summer. While the official ban applied to unincorporated areas in Collin County, the City of Lucas follows the County's lead in outdoor burn bans.

Although the danger of grass fires has been reduced by the rains, residents should still use caution when doing any outdoor burning. As a reminder, if you plan any outdoor burns, you must follow the burn notification procedures as outlined in the City website at www.lucastexas.us. On the home page, choose "City Services", then click on "Public Safety". You will then have an option to click on "Controlled Burn Info."

August 7, 2008 City Council Meeting

- Approved minutes from July 3, July 5, and July 17 Council meetings.
- Approved amendment to agreement between Lucas and Collin Co. for on-site sewage facility extending contract for one year up through and including 9/30/2009.
- Approved amendment to agreement between Lucas and Collin Co. for law enforcement services extending contract for one year up through and including 9/20/2009.
- Approved terminating prior interlocal agreement with Collin Co. and approving new agreement for design and construction of intersection improvements of Country Club Rd at West Lucas Rd., and Country Club Rd at Estates Pkwy.
- Approved termination of design contract for FM1378/FM3286 intersection improvements and awarding of design contract for intersection improvements at Country Club Rd at West Lucas Road, and Country Club Rd. and Estates Pkwy.: both contracts with Freese & Nichols.
- Adopted effective tax rate of .37418 (later corrected to .374177) for 2008/09 fiscal year.
