

IT'S SPRING! ARE YOU PREPARED?

Ahh, Spring! I love this weather, trees budding out, bulbs in bloom, and spring rains. But, it's also Texas, and having lived here for 25 years, I know how quickly the weather can change and how severe it can become.

The Dept. of Homeland Security has run a television ad campaign urging families to create a disaster/emergency plan. What isn't mentioned is the importance of including plans for the furry, hairy, feathery, or wooly animals in our lives. In my case, that's 1 parrot, 4 dogs, and 3 horses. While the parrot and dogs don't present much of a problem – load them in the car and away we go – my much larger family members present more of a challenge. Many of my neighbors here in Lucas have the same issue, so I'd like to share some of the ideas I've gathered and give you a few resources to assist you in developing an emergency plan for those larger furry, hairy, or wooly creatures in your family.

- · Find a safe place Have a list of friends, relatives, boarding facilities, race tracks, show grounds, pastures, stables, fairgrounds, or arenas outside your immediate area and make arrangements ahead of time for them to be taken there. If these animals must be left behind make arrangements in advance with a trusted neighbor, friend or relative to look after them. Leave these people a list of your and your veterinarian and farrier contact numbers. Include information about the animal's food, vaccinations and any medication. Post a copy of this information visibly in your barn and your horse trailer. Keep a copy in the truck you use to pull that trailer.
- · Develop an evacuation plan Keep gas in your truck, keep the trailer ready to hitch up (know where that key to the trailer lock is), and tires inflated. Have maps of the local area and alternate evacuation routes marked to your designated safe place. Make sure that your animals are familiar with being loaded onto a trailer. If you do not have enough trailers to transport all of your animals, contact neighbors or local haulers and establish a network of available resources that will assist with transportation.

Have an evacuation kit – you can purchase these already put together or make your own in an easy-to-carry, waterproof container. Some of the items to include for our equine family members are: bandannas (to use as blindfolds), duct tape, first aid kit, heavy gloves, hoof knife,

- \cdot pick, nippers, & rasp, halters & leads, and wire cutters. Consult your veterinarian when putting together the first aid kit.
- \cdot ID your animals two inexpensive, easy ideas are to braid a luggage tag into tail or mane or use a permanent

Tornado—Make A Plan to Survive

Tornadoes are nature's most violent storms. Spawned from powerful thunderstorms, tornadoes can cause fatalities and devastate a neighborhood in seconds. A tornado appears as a rotating, funnel-shaped cloud that extends from a thunderstorm to the ground with whirling winds that can reach 300 miles per hour. Damage paths can be in excess of one mile wide and 50 miles long. Every state is at some risk from this hazard.

Your first line of information for severe weather will come from your local radio and TV stations.

Tornado Watch – Conditions are right for the formation of a tornado.

Tornado Warning – An actual tornado has been spotted by trained personnel or indicated on radar. Take shelter immediately.

The weather systems that collide to form severe thunderstorms and possibly tornadoes occur more frequently in the spring, usually March though June. The prime time for tornadoes is from 3 to 7 p.m. Although it must be remembered that tornadoes can strike at any time of the day or year and at any place.

The key is to put as many walls as possible between you and the outside!

In homes or small businesses – Take cover in the center part of the structure, on the lowest floor, in a small room such as a closet or bathroom or under sturdy furniture. Stay away from windows and do not attempt to open them.

In schools, shopping centers, or public buildings - stay away from windows and large unsupported areas such as auditoriums or gymnasiums. Move to the pre-designated shelter area. Follow specific instructions by building officials.

In a car, mobile home, or in open country – seek shelter in a substantial shelter or get into the nearest ditch or depression (beware of flash flooding) until the tornado passes. Cover your head with your hands. Never try to outrun a tornado.

Always take cover – most tornado deaths are caused by head injuries from flying debris.

Purchase a NOAA weather radio – by listening you will be able to track the storm's progress well before it arrives in the area. Weather radios can be purchased through local retailers of electronic equipment. Monitoring local amateur radio storm spotters will allow you to know where the tornado is and the direction of travel.

Tips to Save Energy Today

Easy low-cost and no-cost ways to save energy.

- · Install a programmable thermostat to keep your house comfortably warm in the winter and comfortably cool in the summer.
- · Use compact fluorescent light bulbs with the ENERGY STAR® label.
- · Air dry dishes instead of using your dishwasher's drying cycle.
 - · Turn off your computer and monitor when not in use.
- · Plug home electronics, such as TVs and DVD players, into power strips; turn the power strips off when the equipment is not in use (TVs and DVDs in standby mode still use several watts of power).
- Lower the thermostat on your hot water heater to 120°F.
 - · Take short showers instead of baths.
 - · Wash only full loads of dishes and clothes.
- · Drive sensibly. Aggressive driving (speeding, rapid acceleration and braking) wastes gasoline.
- · Look for the ENERGY STAR label on home appliances and products. ENERGY STAR products meet strict efficiency guidelines set by the U.S. Department of Energy and the Environmental Protection Agency.

marker to mark hooves. Keep photos and copies of vaccination records and registrations in a zip lock bag as part of your evacuation kit. This will help to identify your animal should they become loose.

Stage 1 Water Restrictions

The City of Lucas is currently in Stage 1 Water Restrictions. Beginning April 1st through October 31st, watering between the hours of 10 a.m. to 6 p.m. is prohibited.

Drought Contingency Plan

The City of Lucas is currently working on updating our drought contingency plans to be in accordance with North Texas Municipal Water District regulation and State law. The city is required to adopt a set of guidelines by May 2, 2009 that meets the criteria established by NTMWD. The changes that will affect every day usage are as follows.

- 1. Time of day watering is restricted from 10 AM to 6 PM from April 1 through October 31.
- 2. No watering of impervious surfaces.
- 3. No watering during precipitation or freeze events.
- 4. Outdoor lawn and landscape watering limited to twice a week.
- 5. Treated water may not be used to fill or refill ponds.
- 6. At home car washing to be done using a water hose with a shut off nozzle.
- 7. Watering of areas over seeded with cool-season grass (rye, winter or other) is not allowed accept for golf courses.
- 8. Rain/freeze sensors and/or ET Smart controllers required for all new irrigation systems. (already required by local code)

With the upcoming summer season fast approaching if we all give just a little thought to water conservation, it may help to alleviate the need for more stringent regulations in the future.
