### **HOME RULE CHARTER ELECTION RESULTS**

On September 10, 2005, a majority of Lucas voters cast ballots against the adoption of the proposed Home Rule Charter.

For: 251 (37.9%) Against: <u>408</u> (61.6%) Provisional: 3 (0.5%)

### **Next Steps**

The City Council will be appointing commissioners to a new Home Rule Commission to begin work on another Home Rule Charter. An election on the adoption of the charter created by the new commission will be tentatively held on May 13, 2006.



### **NEW SUBDIVISIONS and LOT SIZES**

The City has received several comments from our citizens regarding the number of new developments coming in with lots sizes which are only 1 or 1.5 acres, even though the Future Land Use Plan may call for a 2-acre minimum in a particular area.

How can this happen? The City can only set the zoning district on a piece of land that is within the city limits. Any land that is located in our extra territorial jurisdiction (ETJ), meaning it is unannexed and generally referred to as being "in the county," can be developed however the owner sees fit so long as it complies with any applicable County codes and any City codes enforceable in the ETJ. By state law (Texas Local Government Code 212.003), a municipality cannot enforce zoning regulations in its ETJ.

What can we do about it? Forced annexation is allowed only in certain circumstances and is not allowed for a general-law municipality eligible to adopt a home rule charter, such as Lucas. These laws are enacted by the State of Texas and can only be changed at that level.

### PARKS SURVEY RESULTS

Many thanks to everyone who took the time to fill out the Parks and Open Space survey. The Parks & Open Space Board is guided by your input. The number of voters who responded was equivalent to the number who elected our City Council in the last election. Only about 6% did not want any parkland at all. The table below shows the top 10 choices, the lower the score the better. 86% of respondents were in favor of working with the LISD to share resources. Being able to use athletic fields at night was important to 43% and not important to 43%.

### **OPEN SPACE MASTER PLAN**

The complete parks survey results will be included in a Parks and Open Space Master Plan which is currently being compiled. A master plan is only a framework and is subject to frequent revision based on your input. A master plan is required by all grant giving entities — a necessity if the City is to obtain matching funds for open space and leverage your tax dollars.

Currently, the POS Board has compiled as much of the master plan as its expertise allows. The City Council recently approved the expenditure of funds budgeted in last year's budget to have a professional consultant complete the plan with conceptual drawings, a prioritized list of projects with estimated timelines, recommendations on funding sources, and estimates of acquisition, development and, most important, maintenance costs. This will help the City plan its future open space needs as tax dollars allow. At every step of the way, the POS Board must seek approval from the City Council for any plans, expenditures or grants through the budget process.

In addition, the City now has a Parkland Dedication Ordinance which requires developers to donate either land or funds at the City's discretion towards Open Space within the City.

### **FOREST CREEK PARK**

Many of you may not know about Forest Creek Park, the first neighborhood park in the City. Located near the corner of Orchard Gap and White Rock Trail, this parkland was donated by the developer of Forest Creek Estates to the City long before there was a Parks and Open Space (POS) Board, and it remained open space for many years. Its amenities include pre-school and elementary age playground equipment, bike racks, a small parking area, trees, and a gazebo — a perfect park for daytime play or parties.



The POS Board used the value of the land as a match to obtain funding to install the playground equipment and the gazebo. Last year, the City budgeted funds to improve its usability by planting grass and irrigating the 2 acres. The POS Board plans to add more trees and refurbish the native plant garden which was installed using mostly citizen and corporate donations along with a grant from the Native Plant Society of Texas. The POS Board welcomes your ideas as to what amenities could be added to make this park a gathering place for families. # CLEARLY POSTED HOUSE NUMBERS ARE CRITICAL IN AN EMERGENCY

Something that is taken for granted but is overlooked quite often in Lucas is visible house numbers. A very high percentage of houses in the Lucas area do not have house numbers that can be found by emergency crews at night. Very often addresses are unreadable due to lack of size, overgrown by vegetation or just missing.

Imagine if a family member starts experiencing a heart attack and the rapid response of emergency crews is hampered by the inability of the crews to locate your home because they can't find the proper address.

Response time is critical; seconds lost can mean the difference between life and death. Firefighters, emergency vehicles and personnel may need to find your house number quickly no matter the time of day.

The City of Lucas Municipal Code 5-24.505.1 states: "New and existing buildings shall have approved address numbers, building numbers, or approved building identification placed in a position to be plainly legible and visible from the street or road fronting the property and to the rear of the property. These numbers shall be contrasting with their background. Address numbers shall be Arabic numerals or alphabet letters."

Please help the Lucas VFD by posting your house numbers so that they are visible at night from the road. This simple act may be the difference between life and death.

Coppell was the first city in North Texas recognized as a storm ready community.

James also earned Associates degrees in Fire Science and in Law Enforcement. He has a Master Fire Fighter Certificate, Master Police Officer Certificate, and 20 years as a Licensed Paramedic. James is a recent graduate of the Executive Fire Officer Program at the National Fire Academy in Emmitsburg, Maryland.

James has an Amateur Radio Extra Class License and is Zone Director for Army MARS. He and his wife, Debbie, currently reside in Lucas. They have two grown sons and one granddaughter.




