### Straight Talk from the Mayor



The City of Lucas' intersection improvements project is nearing completion. Reynolds Asphalt and Construction Company is the contractor for the project. The engineering firm of Freese and Nichols, Inc. was the design engineer. The City of Lucas' Public Works Department staff provided engineering oversight and

construction management.

The project will add right-turn lanes at two major intersections within the City. There are two new turn lanes at the intersection of West Lucas Road and Country Club Road, and one at Estates Parkway and Country Club Road. These improvements will help ease congestion at the intersections during peak traffic times, especially in the morning and afternoon.

The intersection improvement project was funded by the City of Lucas and Collin County through an Interlocal Agreement. Collin County participated with 50% of the costs of design and construction, using 2007 Bond funds.

The total cost for design and construction was \$295,506. The County and City each contributed \$147,753 to fund the project. The City used \$70,400 from Thoroughfare Impact Fees, obtained from new residential development, with the remaining \$77,353 from the City's General Fund.

### **Property Fraud Alert**

County Clerk <u>Stacey Kemp</u> has posted a new – and free – online service that will let you know when anyone attempts to change your property's documents on file in Collin County. **Property Fraud Alert** will notify you of any changes made to your personal or business property.

This notification system is set up to help thwart people filing a fraudulent land records with the County Clerk, making it look like they own your home or business property.

And it happens.

Scam artists pick a house to steal, maybe a rental property. They then assume the homeowner's identity using any information they can find on the homeowner,

create fake ID's, forge signatures and notarizations, and file a fraudulent deed transferring the property away from the legitimate homeowner. Next, they record the deed and sell the property or re-mortgage it and pocket the proceeds – and can be long gone before the homeowner is aware of what's happened.

**Property Fraud Alert** is a team effort with the County Clerk to help keep you informed if someone tries to file a land record using your good name.

## Vote Center concept brings added convenience to casting ballots on Election Day

Collin County will introduce the **Election Day Vote Center** concept for special elections slated on Nov. 3, and our <u>Elections Department</u> has tapped a few new resources to make it easier for voters to find a polling location.

Just as early voting allows registered voters to cast ballots at any polling locale before Election Day, a pilot program allows the Vote Center concept to work the same on Nov. 3 at 57 different locations. As long as you're registered in this county, there is no need to worry about which precinct in which you're registered and which polling location applies to that precinct.

Because of that, we've added tools and services to make it easier and more convenient to cast your ballot on that Tuesday.

### Location, location

Since Collin County voters can cast ballots at any vote center, we've tried to make it as easy as possible to find a vote center close to your home, work or wherever you happen to be in the county while the polls are open. If you want to pick your polling locale online, you can logon to our Election Day Polling Location Search, type any county address and zip code, and the interactive map will find the closest poll to you, plus tell you how to get there

We've also posted the master list of all 57 locations, from the Allen Municipal Court Building to Fire Station #5 in McKinney to the Wylie Municipal Complex. While you're viewing the list, take a look to the right hand columns, where we'll have a traffic light to show you whether the poll is being used heavily or not – and an

estimated wait time for each location. Don't have a lot of time to wait in line? Scan for locales that aren't as busy.

#### **Text Service**

Also, from October 31 up through Election Day, we'll be providing a text service where you can send in your zip code and the mPulse messaging service will provide up to three vote center addresses nearest you. If you're interested in this type of service, please sign up for election information emails and we'll get back with you with instructions. This is also where you can register to receive election results as they are updated by our staff.

Remember, Collin County is one of only four Texas counties participating in this state-sponsored pilot program. While the vote center concept might turn out to be how we vote in primaries and general elections in the future, this method is being tapped for the Nov. 3 Special Elections only. For that reason, we're encouraging everyone to "test drive" these tools and cast their vote on Nov. 3.

The League's Legislative Services Department attempts to defeat bills detrimental to city interests, and helps facilitate passage of bills that improve the ability of local government to operate effectively. The League provides in-depth information to its members on legal issues, conducts training seminars for local government officials, and provides a wide variety of information and data helpful to cities. They employ full time attorneys who are available to provide member cities with advice and information on municipal legal matters.

The TML Intergovernmental Employee Benefit Pool provides the City with access to employee benefit programs that are generally lower cost than the open market.

- Approved **RESOLUTION** # **R-2009-10-00343** of the City Council of Lucas, Collin County, Texas designating the *McKINNEY COURIER GAZETTE* the official newspaper of the City of Lucas, Collin County, Texas, for Fiscal Year 2009-2010.
- Approved **ORDINANCE** # 2009-10-00654 of the City of Lucas, Collin County, Texas, finding that the current rates of CoServ Gas LTD. Are unreasonable; approving Coserv Gas LTD.'s revised and uncontested tariffs; setting the effective date of new tariffs as November 1, 2009; finding rate case expenses reasonable; finding that any relief requested by Coserv Gas LTD. not specifically granted herein is denied; finding that the meeting at which this ordinance is passed is open to the public as required by law; providing for notice of this ordinance to Coserv Gas LTD.
