

STRAIGHT TALK FROM THE MAYOR

It's the time of the year when your Council starts the planning process for the new fiscal year that begins each October 1. We go thru the budget in great detail to identify future needs, and to make sure that our tax rate is sufficient to support those needs. Due to past prudent planning, we have been fortunate to enjoy a City tax rate that is dramatically lower than nearly all the other cities in our North Texas area. In fact, in spite of our rising needs, our tax rate has actually gone down since 2005.

As a frame of reference, consider that other Collin County cities with similar populations, (under 10,000 based upon past census data), such as Celina, Princeton, Prosper, Anna, Farmersville, and Melissa, have current tax rates that range from .520000 up to .728394. Our current tax rate is **.374177**. The larger cities in the surrounding areas also have significantly higher tax rates than ours.

Our proposed tax rate for the 2010/2011 fiscal year contemplates no tax increase, remaining at .374177. On August 19th, the first public hearing was held on the proposed tax rate, as well as the proposed budget for the new fiscal year. The second public hearing is scheduled for Sept. 2, at which time Council will discuss and consider adopting both the budget and the new tax rate.

The proposed budget contemplates no cutting of personnel or services during the coming year. A copy of this budget is available at City Hall and is posted on the City website.

We are fortunate to have excellent City staff, all of whom understand the importance of prudent financial management. We are rapidly paying down all of our debts, and will continue to do so.

In these tough economic times, your council and city staff are committed to maintaining a balanced budget and holding the line on tax increases.



City of Lucas' Community Emergency Response Team (CERT)

After 8 weeks of classes and a challenging Disaster Day exercise, Lucas has its first official CERT (Community Emergency Response Team) members. Thanks to a grant received by the Lucas Volunteer Fire Department, team members received training to be able to assist in the event of a catastrophic disaster. McKinney Fire Department members with CERT training taught classes in areas covering disaster preparedness, fire safety, emergency medical operations (including triage and first aid), light search and rescue operation and CERT organization .

A brief power point presentation will be made at the Council Workshop on September 16. The presentation has actual pictures of the training involved as well as the Disaster Day exercise. Safe Prescription drug disposal Saturday, September 25th

On September 25, 2010, DEA will coordinate a collaborative effort with state and local law enforcement agencies to remove potentially dangerous controlled substances from our nation's medicine cabinets. Collection activities will take place from 10:00 a.m. through 2:00 p.m. at sites established throughout the country. The National Take-Back Day provides an opportunity for the public to surrender expired, unwanted, or unused pharmaceutical controlled substances and other medications for destruction. These drugs are a potential source of supply for illegal use and an unacceptable risk to public health and safety.

This one-day effort is intended to bring national focus to the issue of increasing pharmaceutical controlled substance abuse.

- * The program is anonymous.
- * Prescription and over the counter solid dosage medications, i.e. tablets and capsules accepted.
- * Intra-venous solutions, injectables, and needles will not be accepted.
- * Illicit substances such as marijuana or methamphetamine are not a part of this initiative.


