Background Information:

Advertisements for banking services were published on Thursday, November 10 and 17 in the Allen American newspaper. Proposals were accepted until 2:00 pm Tuesday, November 29, 2016. Proposals were evaluated on the following criteria:

•	Service Availability	30%
•	Deposit Interest Rates	15%
•	Cost of Service	25%
•	Safety and Creditworthiness of the Bank	30%

The City received proposals from American National Bank of Texas and Legacy Texas Bank that were evaluated based on the criteria listed above.

A copy of each proposal is available for viewing in the City Secretary's office.

Citizen Summary:

The City's Bank depository contract expires December 31, 2016. The City sent out request for proposals (RFP) for banking services on November 10, 2016. This request for proposals represents the cash management goals, specifies required qualifications, banking services required, estimated activity volumes on all accounts, method and terms of compensation, submission instructions and contract award provisions. Through this contract the City intends to minimize banking costs, improve operational efficiency, and maximize investment capabilities.

Staff Evaluation Summary

City staff received proposals from American National Bank of Texas and Legacy Texas Bank. The proposals were evaluated based on service availability, deposit interest rates, cost of service, and safety and creditworthiness of the bank.

After evaluating both proposals, the decision was made to recommend awarding the banking contract to American National Bank of Texas in Allen, Texas.

The highlights that contributed to our decision were as follows:

Service Availability:

- Account Executive has more than 38 years of experience. Over 32 years
 working with public fund customers in the Allen, Texas market. One of the
 oldest community banks and has been working with the public sector for
 over 50 years.
- Bank branch close by with a live person to speak to and an attentive customer service team that can be reached by a local telephone number.
- Late cut-off times (4:30 pm) for incoming/outgoing wires, and ACH files
- Online service 24 hours a day with immediate access to account information

Deposit Interest Rates:

• Interest rate equal to the current ANBTX Public Fund Money Market Rate plus .15% (currently .20%) for balances in excess of \$3 million.

Cost of Service:

• Free of charge for all banking services with an average \$3 million compensating balance.

Safety and Creditworthiness of bank:

- Accounts are reconciled for fraud prevention and checked daily.
- Pledged securities of 105% less the amount of FDIC coverage



Staff Evaluation Summary

- Balances are verified daily and compared to pledged securities market value to insure adequate pledge dollars.
- Securities are held in safekeeping at the Federal Home Loan Bank of Dallas
- Currently provides service to 70 school districts, cities, and counties and manages over \$260 million in public deposits.

The other bank that we received a proposal from was Legacy Texas. Some of the key factors that were concerns for us were as follows:

Service Availability:

- Very little information was provided to the years of public sector experience that the staff that would support the account had. Account Executive had 38 years banking experience specializing in lending with three different banks.
- The cutoff times were a little shorter than ANB of Texas (4:00 pm).

Costs of Services:

- Service fees were higher for ACH processing, chargebacks, cash management fee, account maintenance fee, and branch credits and debits.
- Compensating balance requirement ranged from \$5 to \$14 million on non-interest bearing account.

This Bank Depository Agreement (the "Agreement") is made by and between the City of Lucas, Texas, a municipal corporation existing under the laws of the State of Texas (the "City"), and American National Bank of Texas (the "Bank") a bank chartered in the State of Texas, (each a "Party" and collectively the "Parties"), acting by and through their authorized representatives.

RECITALS:

WHEREAS, the City advertised and received bids for a depository contract pursuant to and in accordance with Chapter 105 of the Texas Local Government Code, as amended; and

WHEREAS, the City received responses from banks designed to be designated as the City's depository; and

WHEREAS, the City Council did find and conclude the Bank offered a proposal containing the most favorable terms and conditions for the handling of the City's deposited funds and designated the Bank as the City's depository bank;

NOW THEREFORE, the City will use the Bank's facilities and services in accordance with the following terms and conditions set out herein.

Article I Designation as Depository

- 1.1 <u>Term.</u> The City, through action of the City Council, hereby designates the Bank as its depository for banking services for a three-year period commencing December 27, 2016 ("Effective Date"), through December 27, 2019 ("Initial Term").
- 1.2 The City shall have the right and option to renew this Agreement for two (2) additional one (1) year periods (each such one-year period after the Initial Term being an "Additional Term") under the same terms and conditions as provided herein by giving written notice to the Bank of the City's election to so extend the term hereof prior to the expiration of the Initial Term or Additional Term.

Article II Contract Documents

- 2.1 Every provision of the documents below is incorporated into this Agreement by reference. The documents referenced below are in descending order of precedence. Any conflict between or among any of the documents shall be resolved in favor of the document with higher precedence. These documents shall be referred to collectively as "Contract Documents."
 - (a) This Agreement;

- (b) The City's 2016 Request for Proposal for Banking Services (Exhibit "A"); and
- (c) The Bank's Response to the City's Proposal (Exhibit "B").

Article III Scope of Services

- 3.1 The Bank agrees to provide those services as described in Exhibits "A" and "B" attached hereto.
- 3.2 The Bank shall faithfully perform all of its duties and obligations required by the laws of the State of Texas for public funds depositories and shall, upon presentation, pay all checks drawn on it against collected funds on demand deposits, and shall, at the expiration of the Agreement, turn over to its successor all funds, City–owned securities, property and things of value as held as depository.
- 3.3 The City shall have the power to determine and designate the character and amount of the funds to be deposited in the Bank. The City may arrange for time deposits and Bank may accept such deposits subject to the terms of the Bank's Response.
- 3.4 The Bank shall, on a semi-annual basis, analyze the City's use of banking services and make recommendations to the City that will maximize financial return and decrease the City's overall cost of banking services.

Article IV Collateral

- 4.1 The City time and demand deposits, inclusive of interest, in excess of the Federal Deposit Insurance Corporation (FDIC) insurance shall be secured at all times by collateral, acceptable to the City and in accordance with the Public Funds Collateral Act (Texas Government Code 2257), pledged by the Bank and held in trust by the Custodian in an amount equal to at least 105% of the total of those funds, Custodian shall provide a monthly report of the collateral directly to the Authority.
- 4.2 Such pledged securities shall be subject only to the joint written instructions of both (a) authorized representatives of the City and (b) specifically authorized representatives of the Bank. The Bank shall have the right, with the prior written consent of the Bank, to substitute or replace any or all of the pledged securities with collateral acceptable to the Bank. All investments shall meet the requirements set forth in Chapter 2256, Texas Public Funds Investment Act, Texas Government Code.

Article V Financial Position

The Bank shall provide a statement of its financial position on at least a quarterly basis. The Bank shall provide an annual statement audited by its independent auditors including a letter as to its "fair representation".

Article VI Authorized Authority Representatives

For the term of this Agreement, the City and Bank designate the individuals listed in Exhibit "C" as authorized to represent and act for the City in any and all matters including collateral assignment and substitution, execution of the agreements and transfer of funds. Any change in these representatives shall be made in writing.

Article VII Bank Compensation

The Bank shall be compensated for any and all services rendered to the City under this Agreement on a Cost Per Service Unit or monthly charge basis as set forth in the service charges listed on Exhibit "B." The Bank agrees to offset monthly service fees against its customary earnings credit for balances in City's non-interest bearing accounts. Net insufficiencies in earnings credits shall be charged on an annual basis.

Article VIII Default

- 8.1 The Bank shall be in default if it fails to pay all or part of a demand deposit, a matured time deposit, or a matured certificate of deposit, including accrued but unpaid interest, at a specified maturity date. The Bank shall also be in default if ruled "bankrupt", "insolvent" or "failed" by a federal or state banking regulator, or if a receiver is appointed for the Bank.
- 8.2 In the event of a default, failure or insolvency of the Bank, the City shall be deemed to have vested full title to all securities pledged under this Agreement. The City is empowered to take possession of and transfer and or sell any and all securities. If the security is liquidated, any proceeds over the defaulted amount, plus expenses related to liquidation, shall be returned to the Bank. This power is in addition to other remedies which the City may have under this Agreement and without prejudice to its rights to maintain any suit in any court for redress of injuries sustained by the City under this Agreement.

Article IX Miscellaneous

9.1 <u>Governing Law.</u> This Agreement is governed by the laws of the State of Texas; and exclusive venue for any action shall be in Collin County, Texas. The Parties agree to submit to the jurisdiction of said court.

- 9.2 <u>Review</u>. There shall be a review of the services of the Bank every six (6) months to evaluate the work relationship between the City and the Bank. The objective of the review shall be to address any problems and to discuss the procedures involved in protecting the City's funds and pledged collateral.
- 9.3 <u>Notice</u>. The Bank shall use its best efforts to notify the Authority in writing within ten (10) days of any changes in federal or state regulations or laws that would thereafter materially affect the Bank Depository Agreement. The Bank shall also notify the Authority of any services that become available to the Authority throughout the Agreement. Any notice required to be given by any term of this Agreement or otherwise may be given as follows:

- 9.4 <u>Non-Assignability</u>. This Agreement is not assignable in whole or part but is binding on the Parties, their successors and assigns.
- 9.5 <u>Termination</u>. Notwithstanding any provision of this Agreement to the contrary, this Agreement may be terminated by either Party, without cause and without liability (except for continuing obligations during such period), upon ninety (90) days advance written notice to the other Party. The Bank shall provide an extension period not to exceed ninety (90) days for the transition to a new depository bank.
- 9.6 <u>Severability</u>. In the event any section, subsection, paragraph, sentence, phrase or word herein is held invalid, illegal or unconstitutional, the balance of this Agreement, shall be enforceable and shall be enforced as if the Parties intended at all times to delete said invalid section, subsection, paragraph, sentence, phrase or word; and such invalid, illegal, unconstitutional or unenforceable section, subsection, paragraph, sentence, phrase or word shall be substituted by a section, subsection, paragraph, sentence, phrase or word as near in substance thereto as may be valid, legal, constitutional and enforceable.

- 9.7 <u>Entire Agreement</u>. This Agreement embodies the complete agreement of the Parties hereto, superseding all oral or written previous and contemporary agreements between the Parties and relating to the matters in this Agreement, and except as otherwise provided herein cannot be modified without written agreement of the Parties to be attached to and made a part of this Agreement.
- 9.8 <u>Incorporation of Recitals</u>. The determinations recited and declared in the preambles to this Agreement are hereby incorporated herein as part of this Agreement.
- 9.9 <u>Exhibits</u>. All exhibits to this Agreement are incorporated herein by reference for all purposes wherever reference is made to the same.
- 9.10 <u>Amendments</u>. This Agreement may be amended by the mutual agreement of the Parties to it in writing and attach to and incorporate it in this Agreement.
- 9.11 <u>Authorization</u>. By executing this Agreement, each Party represents that they have full capacity and authority to grant all rights and assume all obligations that they have granted and assumed under this Agreement and that this Agreement has been authorized by the governing party of the respective Party.
- 9.12 <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original and constitute one and the same instrument.

Discuss and give direction to the City Manager regarding 1) proceeding with a professional services contract with Birkhoff, Hendricks & Carter, LLP in the amount of \$91,130 for the design of the W. Lucas Road/Stinson Road Intersection Project and 2) amend the FY 16-17 Budget Road Capacity Improvements account (21-8210-491-123) for funding of the Winningkoff Reverse Curve Construction Project.

Background Information:

After several accidents and complaints from motorist, an initial request was made for \$840,000 (Road Capacity Improvements 21-8210-491-123) in FY 16-17 budget for improvements to the following:

- 1) W. Lucas Road/Stinson Road Intersection
- 2) Estates Parkway/Rock Ridge Road Intersection

W. Lucas Road/Stinson Road intersection has risen in importance during the past two years. Three roadway closing accidents and numerous complaints from residence using the intersection have raised concerns regarding the functionality of this intersection. Several larger vehicles have fallen into the drainage ditches trying to make right turns. School busses and trucks with stock/equipment trailers are unable to negotiate the turn given the narrowness of Stinson Road, the lack of sufficient radii, and stacking traffic.

Multiple projects were planned to be funded out of the \$2,000,000 Certificate of Obligation, the current states of those funds have been applied in the following way:

The Blondy Jhune Bridge contingency represents 20% of the construction cost and is held in reserve in case of unforeseen conflicts and issues, but it may not be used in its entirety. The contingency for this project is **unfunded**. Staff is anticipating encumbering approximately \$50,000 of the remaining funding available to fix the AT&T conflict at the east bridge leaving **\$38,637**.

The Road Capacity Improvements (21-8210-491-123) is funded by impact fees and is limited in how the funds can be used. Capacity projects such as adding lanes, widening a narrow roadway to two full lanes, and adding turn lanes are eligible to use impact fees. The W. Lucas Road/Stinson Road intersection is by definition a capacity project. The schematic contemplates providing a right and left turn lane for northbound Stinson Road, widening southbound Stinson Road and the radii at the intersection to accommodate east to south right turns, and adding a west to south left turn lane on W. Lucas Road.

Notes:

- Winningkoff Reverse Curve cost estimate is at a 60% level and includes a 15% contingency.
- W. Lucas Road/Stinson Road Intersection construction cost estimate is at the 1% level and includes a 15% contingency.
- Staff is recommending redesigning the Estates Parkway/Rock Ridge Road Intersection and coordinate with the larger TxDOT Angel Parkway (FM 2551) project to be let in 2018 or 2019 to potentially reduce cost.

This agreement ("Agreement") is made by and between the City of Lucas, Texas ("City") and <u>Birkhoff, Hendricks & Carter, L.L.P.</u>, a <u>Professional Engineering Firm</u> ("Professional") (each a "Party" and collectively the "Parties"), acting by and through their authorized representatives.

RECITALS:

WHEREAS, the City desires in connection with the <u>Stinson Road and Lucas Road (F.M. 1378) Paving and Drainage Improvements Project</u> (the "Project") to engage the services of the Professional as an independent contractor, and not as an employee, to provide the services described in Exhibit "A" (the "Scope of Services") on the terms and conditions set forth in this Agreement; and

WHEREAS, the Professional desires to render professional services for the City on the terms and conditions set forth in this Agreement;

NOW THEREFORE, in exchange for the mutual covenants set forth herein, and other valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the Parties agree as follows:

Article I Term

- 1.1 This Agreement shall commence on the last date of execution hereof ("Effective Date") and continue until completion of the services, unless sooner terminated as provided herein.
- 1.2 Either Party may terminate this Agreement by giving thirty (30) days prior written notice to the other Party. In the event of such termination the Professional shall deliver to City all finished and unfinished documents, data, studies, surveys, drawings, maps, models, reports, photographs or other items prepared by the Professional in connection with this Agreement. Professional shall be entitled to compensation for any services completed to the reasonable satisfaction of the City in accordance with this Agreement prior to such termination.

Article II Scope of Service

2.1 The Professional shall perform the services in connection with the Project as set forth in Exhibit "A", Scope of Services.

- 2.2 The City shall, prior to commencement of services, provide the Professional with the information set forth in Exhibit "D", if any.
- 2.3 The Parties acknowledge and agree that any and all opinions provided by the Professional in connection with the Scope of Services represent the professional judgment of the Professional, in accordance with the professional standard of care applicable by law to the services performed hereunder.
- Upon execution of this Agreement the City has the right to use the Professional's instruments of service for purposes of constructing, using, maintaining, altering and adding to the Project, provided that the City substantially performs its obligations, including prompt payment of all sums when due, under this Agreement. The City's Project Contractor, Construction Manager, Subcontractors, Sub-subcontractors, and material or equipment suppliers, as well as the City's consultants and separate contractors, may reproduce applicable portions of the instruments of service for use in performing services or construction for the Project. Upon payment of all amounts due Professional hereunder, all materials and reports prepared by the Professional in connection with this Agreement shall become the property of the City. The City shall have the right to publish, disclose, distribute and otherwise use such materials and reports only for those purposes for which they were intended. Subject to the foregoing, Professional shall upon completion of the services, or earlier termination, provide the City with reproductions of all drawings, materials, specifications, reports, maps, and exhibits prepared by Professional pursuant to the Scope of Services. The reproductions shall include a compact disc containing all construction plan sheets in a ".dwg" format and a scanned 24" x 36" black & white "Tiff" images at 400 dpi resolution and in electronic format as requested by the City or required in Exhibit "A".

Article III Schedule of Work

The Professional agrees to complete the required services in accordance with the Project Schedule outlined in Exhibit "B".

Article IV Compensation and Method of Payment

4.1 Professional will be compensated in accordance with the payment schedule and amounts set forth in Exhibit "C" (the "Compensation Schedule"). Unless otherwise provided herein, payment to the Professional shall be monthly based on the Professional's monthly progress report and detailed monthly itemized statement for services that shows the names of the Professional's employees, agents, contractors performing the services, the time worked, the actual services performed the rates charges for such service, reimbursable expenses, the total amount of fee earned to date and the amount due and payable as of the current statement, in a form reasonably acceptable to the City. Monthly statements shall include authorized non-salary expenses with supporting itemized invoices and documentation. The City shall pay such monthly statements within thirty (30) days after receipt and City verification of the services and expenses unless otherwise provided herein. The final payment of the compensation shall be

made after satisfactory completion of the services following the City acceptance of the design, and the submittal of "AS BUILT" drawings", or record drawings as applicable.

4.2 Unless otherwise provided in Exhibit "C" the Professional shall be responsible for all expenses related to the services provided pursuant to this Agreement including, but not limited to, travel, copying and facsimile charges, telephone, internet and email charges.

Article V Devotion of Time; Personnel; and Equipment

- 5.1 The Professional shall devote such time as reasonably necessary for the satisfactory performance of the services under this Agreement. Should the City require additional services not included under this Agreement, the Professional shall make reasonable effort to provide such additional services within the time schedule without decreasing the effectiveness of the performance of services required under this Agreement, and shall be compensated for such additional services on a time and materials basis, in accordance with Professional's standard hourly rate schedule, or as otherwise agreed between the Parties.
- 5.2 To the extent reasonably necessary for the Professional to perform the services under this Agreement, the Professional shall be authorized to engage the services of any agents, assistants, persons, or corporations that the Professional may deem proper to aid or assist in the performance of the services under this Agreement. The Professional shall provide written notice to and approval from the City prior to engaging services not referenced in Exhibits "A" or "C". The cost of such personnel and assistance shall be included as part of the total compensation to be paid Professional hereunder, and shall not otherwise be reimbursed by the City unless provided differently herein.
- 5.3 The Professional shall furnish the facilities, equipment and personnel necessary to perform the services required under this Agreement unless otherwise provided herein.
- 5.4 The Professional shall submit monthly progress reports and attend monthly progress meetings scheduled by the City or more frequently as may be required by the City from time to time based upon Project demands. Each progress report shall detail the work accomplished and special problems or delays experienced on the Project during the previous report period, and the planned work activities and special problems or delays anticipated for the next report period.

Article VI Miscellaneous

6.1 <u>Entire Agreement</u>. This Agreement constitutes the sole and only agreement between the Parties and supersedes any prior understandings written or oral agreements between the Parties with respect to this subject matter.

- 6.2 <u>Assignment</u>. The Professional may not assign this Agreement without the prior written consent of City. In the event of an assignment by the Professional to which the City has consented, the assignee shall agree in writing with the City to personally assume, perform, and be bound by all the covenants, and obligations contained in this Agreement.
- 6.3 <u>Successors and Assigns</u>. Subject to the provisions regarding assignment, this Agreement shall be binding on and inure to the benefit of the Parties to it and their respective heirs, executors, administrators, legal representatives, successors and assigns.
- 6.4 <u>Governing Law</u>. The laws of the State of Texas shall govern this Agreement without regard to any conflict of law rules; and venue for any action concerning this Agreement shall be in the State District Court of Collin County, Texas. The Parties agree to submit to the personal and subject matter jurisdiction of said court.
- 6.5 <u>Amendments</u>. This Agreement may be amended by the mutual written agreement of the Parties.

It is understood and agreed by and between the Parties that the Professional in satisfying the conditions of this Agreement, is acting independently, and that the City assumes no responsibility or liabilities to any third party in connection with these actions. 6.10 Insurance.

- (a) Professional shall during the term hereof maintain in full force and effect the following insurance: (i) a comprehensive general liability policy of insurance for bodily injury, death and property damage insuring against all claims, demands or actions relating to the Professional's performance of services pursuant to this Agreement with a minimum combined single limit of not less than \$1,000,000.00 per occurrence for injury to persons (including death), and for property damage: (ii) policy of automobile liability insurance covering any vehicles owned and/or operated by Professional, its officers, agents, and employees, and used in the performance of this Agreement with policy limits of not less than \$500,000.00 combined single limit and aggregate for bodily injury and property damage; (iii) statutory Worker's Compensation Insurance at the statutory limits and Employers Liability covering all of Professional's employees involved in the provision of services under this Agreement with policy limit of not less than \$500,000.00; and (iv) Professional Liability covering negligent acts, errors and omissions in the performance of professional services with policy limit of not less than \$2,000,000.00 per claim and \$2,000,000.00 in the aggregate.
- (b) All policies of insurance shall be endorsed and contain the following provisions: (1) name the City, its officers, and employees as additional insureds as to all applicable coverage with the exception of Workers Compensation Insurance and Professional Liability; and (2) provide for at least thirty (30) days prior written notice to the City for cancellation of the insurance; (3) provide for a waiver of subrogation against the City for injuries, including death, property damage, or any other loss to the extent the same is covered by the proceeds of insurance, except

THE PROFESSIONAL'S OBLIGATIONS UNDER THIS SECTION SHALL NOT BE LIMITED TO THE LIMITS OF COVERAGE OF INSURANCE MAINTAINED OR REQUIRED TO BE MAINTAINED BY PROFESSIONAL UNDER THIS AGREEMENT. THIS PROVISION SHALL SURVIVE THE TERMINATION OF THIS AGREEMENT.
- 6.12 <u>Counterparts</u>. This Agreement may be executed by the Parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts shall together constitute one and the same instrument. Each counterpart may consist

 of any number of copies hereof each signed by less than all, but together signed by all of the Parties hereto.

STINSON ROAD AND LUCAS ROAD (FM 1378) PAVING & DRAINAGE IMPROVEMENTS PROJECT

General Project Scope:

This project includes paving and drainage improvements to Stinson Road at Lucas Road (F.M. 1378) and adds a left turn lane on Lucas Road. Exhibit "E" contains a project location map.

Stinson Road will be widened to accommodate two northbound lanes at the intersection with Lucas Road; one lane for traffic turning westbound (left) and one lane for traffic turning eastbound (right). The third lane on Stinson will be for southbound traffic. The existing culvert underneath Stinson Road parallel to Lucas Road will be removed and replaced with a culvert which adequately conveys the TxDOT 25-year storm event.

Lucas Road will be widened to accommodate a left turn lane at Stinson Road.

Part I: Final Design Phase

This agreement ("Agreement") is made by and between the City of Lucas, Texas ("City") and <u>Birkhoff, Hendricks & Carter, L.L.P.</u>, a <u>Professional Engineering Firm</u> ("Professional") (each a "Party" and collectively the "Parties"), acting by and through their authorized representatives.

RECITALS:

WHEREAS, the City desires in connection with the Winningkoff Road Reverse Curve Paving and Drainage Improvements Project (the "Project") to engage the services of the Professional as an independent contractor, and not as an employee, to provide the services described in Exhibit "A" (the "Scope of Services") on the terms and conditions set forth in this Agreement; and

WHEREAS, the Professional desires to render professional services for the City on the terms and conditions set forth in this Agreement;

NOW THEREFORE, in exchange for the mutual covenants set forth herein, and other valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the Parties agree as follows:

Article I Term

- 1.1 This Agreement shall commence on the last date of execution hereof ("Effective Date") and continue until completion of the services, unless sooner terminated as provided herein.
- 1.2 Either Party may terminate this Agreement by giving thirty (30) days prior written notice to the other Party. In the event of such termination the Professional shall deliver to City all finished and unfinished documents, data, studies, surveys, drawings, maps, models, reports, photographs or other items prepared by the Professional in connection with this Agreement. Professional shall be entitled to compensation for any services completed to the reasonable satisfaction of the City in accordance with this Agreement prior to such termination.

Article II Scope of Service

2.1 The Professional shall perform the services in connection with the Project as set forth in Exhibit "A", Scope of Services.

- 2.2 The City shall, prior to commencement of services, provide the Professional with the information set forth in Exhibit "D", if any.
- 2.3 The Parties acknowledge and agree that any and all opinions provided by the Professional in connection with the Scope of Services represent the professional judgment of the Professional, in accordance with the professional standard of care applicable by law to the services performed hereunder.
- Upon execution of this Agreement the City has the right to use the Professional's 2.4 instruments of service for purposes of constructing, using, maintaining, altering and adding to the Project, provided that the City substantially performs its obligations, including prompt payment of all sums when due, under this Agreement. The City's Project Contractor, Construction Manager, Subcontractors, Sub-subcontractors, and material or equipment suppliers, as well as the City's consultants and separate contractors, may reproduce applicable portions of the instruments of service for use in performing services or construction for the Project. Upon payment of all amounts due Professional hereunder, all materials and reports prepared by the Professional in connection with this Agreement shall become the property of the City. The City shall have the right to publish, disclose, distribute and otherwise use such materials and reports only for those purposes for which they were intended. Subject to the foregoing, Professional shall upon completion of the services, or earlier termination, provide the City with reproductions of all drawings, materials, specifications, reports, maps, and exhibits prepared by Professional pursuant to the Scope of Services. The reproductions shall include a compact disc containing all construction plan sheets in a ".dwg" format and a scanned 24" x 36" black & white "Tiff" images at 400 dpi resolution and in electronic format as requested by the City or required in Exhibit "A".

Article III Schedule of Work

The Professional agrees to complete the required services in accordance with the Project Schedule outlined in Exhibit "B".

Article IV Compensation and Method of Payment

4.1 Professional will be compensated in accordance with the payment schedule and amounts set forth in Exhibit "C" (the "Compensation Schedule"). Unless otherwise provided herein, payment to the Professional shall be monthly based on the Professional's monthly progress report and detailed monthly itemized statement for services that shows the names of the Professional's employees, agents, contractors performing the services, the time worked, the actual services performed the rates charges for such service, reimbursable expenses, the total amount of fee earned to date and the amount due and payable as of the current statement, in a form reasonably acceptable to the City. Monthly statements shall include authorized non-salary expenses with supporting itemized invoices and documentation. The City shall pay such monthly statements within thirty (30) days after receipt and City verification of the services and expenses unless otherwise provided herein. The final payment of the compensation shall be

made after satisfactory completion of the services following the City acceptance of the design, and the submittal of "AS BUILT" drawings", or record drawings as applicable.

4.2 Unless otherwise provided in Exhibit "C" the Professional shall be responsible for all expenses related to the services provided pursuant to this Agreement including, but not limited to, travel, copying and facsimile charges, telephone, internet and email charges.

Article V Devotion of Time; Personnel; and Equipment

- 5.1 The Professional shall devote such time as reasonably necessary for the satisfactory performance of the services under this Agreement. Should the City require additional services not included under this Agreement, the Professional shall make reasonable effort to provide such additional services within the time schedule without decreasing the effectiveness of the performance of services required under this Agreement, and shall be compensated for such additional services on a time and materials basis, in accordance with Professional's standard hourly rate schedule, or as otherwise agreed between the Parties.
- 5.2 To the extent reasonably necessary for the Professional to perform the services under this Agreement, the Professional shall be authorized to engage the services of any agents, assistants, persons, or corporations that the Professional may deem proper to aid or assist in the performance of the services under this Agreement. The Professional shall provide written notice to and approval from the City prior to engaging services not referenced in Exhibits "A" or "C". The cost of such personnel and assistance shall be included as part of the total compensation to be paid Professional hereunder, and shall not otherwise be reimbursed by the City unless provided differently herein.
- 5.3 The Professional shall furnish the facilities, equipment and personnel necessary to perform the services required under this Agreement unless otherwise provided herein.
- 5.4 The Professional shall submit monthly progress reports and attend monthly progress meetings scheduled by the City or more frequently as may be required by the City from time to time based upon Project demands. Each progress report shall detail the work accomplished and special problems or delays experienced on the Project during the previous report period, and the planned work activities and special problems or delays anticipated for the next report period.

Article VI Miscellaneous

6.1 <u>Entire Agreement</u>. This Agreement constitutes the sole and only agreement between the Parties and supersedes any prior understandings written or oral agreements between the Parties with respect to this subject matter.

- 6.2 <u>Assignment</u>. The Professional may not assign this Agreement without the prior written consent of City. In the event of an assignment by the Professional to which the City has consented, the assignee shall agree in writing with the City to personally assume, perform, and be bound by all the covenants, and obligations contained in this Agreement.
- 6.3 <u>Successors and Assigns</u>. Subject to the provisions regarding assignment, this Agreement shall be binding on and inure to the benefit of the Parties to it and their respective heirs, executors, administrators, legal representatives, successors and assigns.
- 6.4 <u>Governing Law</u>. The laws of the State of Texas shall govern this Agreement without regard to any conflict of law rules; and venue for any action concerning this Agreement shall be in the State District Court of Collin County, Texas. The Parties agree to submit to the personal and subject matter jurisdiction of said court.
- 6.5 <u>Amendments</u>. This Agreement may be amended by the mutual written agreement of the Parties.
- 6.6 <u>Severability</u>. In the event any one or more of the provisions contained in this Agreement shall for any reason be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provisions, and the Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained in it.
- 6.7 <u>Independent Contractor</u>. It is understood and agreed by and between the Parties that the Professional in satisfying the conditions of this Agreement, is acting independently, and that the City assumes no responsibility or liabilities to any third party in connection with these actions. All services to be performed by Professional pursuant to this Agreement shall be in the capacity of an independent contractor, and not as an agent or employee of the City. Professional shall supervise the performance of its services and shall be entitled to control the manner and means by which its services are to be performed, subject to the terms of this Agreement.
- 6.8 <u>Right-of-Access</u>. The Professional shall not enter onto private property without lawful right-of-access to perform the required surveys, or other necessary investigations. The Professional will take reasonable precautions to minimize damage to the private and public property in the performance of such surveys and investigations. Any right-of-access to public or private property shall be obtained in accordance with the Scope of Services.

6.10 Insurance.

- (a) Professional shall during the term hereof maintain in full force and effect the following insurance: (i) a comprehensive general liability policy of insurance for bodily injury, death and property damage insuring against all claims, demands or actions relating to the Professional's performance of services pursuant to this Agreement with a minimum combined single limit of not less than \$1,000,000.00 per occurrence for injury to persons (including death), and for property damage; (ii) policy of automobile liability insurance covering any vehicles owned and/or operated by Professional, its officers, agents, and employees, and used in the performance of this Agreement with policy limits of not less than \$500,000.00 combined single limit and aggregate for bodily injury and property damage; (iii) statutory Worker's Compensation Insurance at the statutory limits and Employers Liability covering all of Professional's employees involved in the provision of services under this Agreement with policy limit of not less than \$500,000.00; and (iv) Professional Liability covering negligent acts, errors and omissions in the performance of professional services with policy limit of not less than \$2,000,000.00 per claim and \$2,000,000.00 in the aggregate.
- (b) All policies of insurance shall be endorsed and contain the following provisions:

 (1) name the City, its officers, and employees as additional insureds as to all applicable coverage with the exception of Workers Compensation Insurance and Professional Liability; and (2) provide for at least thirty (30) days prior written notice to the City for cancellation of the insurance; (3) provide for a waiver of subrogation against the City for injuries, including death, property damage, or any other loss to the extent the same is covered by the proceeds of insurance, except

- for Professional Liability Insurance. The Professional shall provide written notice to the City of any material change of or to the insurance required herein.
- (c) All insurance companies providing the required insurance shall be authorized to transact business in Texas and rated at least "A" by AM Best or other equivalent rating service.
- (d) A certificate of insurance and copies of the policy endorsements evidencing the required insurance shall be submitted prior to commencement of services and upon request by the City.

PROFESSIONAL HEREBY WAIVES ALL CLAIMS AGAINST CITY, ITS OFFICERS, AGENTS AND EMPLOYEES (COLLECTIVELY REFERRED TO IN THIS SECTION AS "CITY") FOR DAMAGE TO ANY PROPERTY OR INJURY TO, OR DEATH OF, ANY PERSON TO THE EXTENT ARISING AT ANY TIME AND FROM ANY CAUSE OTHER THAN THE NEGLIGENCE OR WILLFUL MISCONDUCT OF CITY OR BREACH OF CITY'S OBLIGATIONS HEREUNDER. PROFESSIONAL AGREES TO INDEMNIFY AND SAVE HARMLESS CITY FROM AND AGAINST LIABILITIES, DAMAGES, CLAIMS, SUITS, COSTS (INCLUDING **REASONABLE ATTORNEYS'** COSTS. **FEES AND COSTS** INVESTIGATION) AND ACTIONS OF ANY KIND BY REASON OF INJURY TO OR DEATH OF ANY PERSON OR DAMAGE TO OR LOSS OF PROPERTY TO THE EXTENT CAUSED BY THE PROFESSIONAL'S NEGLIGENT PERFORMANCE OF SERVICES UNDER THIS AGREEMENT OR BY REASON OF ANY NEGLIGENT ACT OR OMISSION ON THE PART OF PROFESSIONAL, ITS OFFICERS, DIRECTORS, SERVANTS, EMPLOYEES, REPRESENTATIVES, CONSULTANTS, LICENSEES, SUCCESSORS OR PERMITTED ASSIGNS (EXCEPT WHEN SUCH LIABILITY, CLAIMS, SUITS, COSTS, INJURIES, DEATHS OR DAMAGES ARISE FROM OR ARE ATTRIBUTED TO NEGLIGENCE OF THE CITY, IN WHOLE OR IN PART, IN WHICH CASE PROFESSIONAL SHALL INDEMNIFY CITY ONLY TO THE EXTENT OR PROPORTION OF NEGLIGENCE ATTRIBUTED TO PROFESSIONAL AS **DETERMINED BY** A COURT OR OTHER FORUM OF COMPETENT JURISDICTION). THIS PROVISION SHALL SURVIVE THE TERMINATION OF THIS AGREEMENT.

Exhibit "A" Scope of Services

WINNINGKOFF ROAD REVERSE CURVE PAVING & DRAINAGE IMPROVEMENTS PROJECT

General Project Scope:

This project includes paving and drainage improvements through the reverse curve in Winningkoff Road. Exhibit "E" contains a project location map. The existing pavement through each of the 90-degree turns will be reconstructed with reinforced concrete at a width to accommodate school buses passing each other through the turns. During the preliminary engineering phase, AutoTURN simulations will be run through the reverse curve using a 36-ft long school bus as the design vehicle. We will prepare a schematic exhibit illustrating the limits of reconstruction. Exhibit "F" contains a typical section for the roadway from the Winninkoff Road Pavement Section Recommendations Report dated January 14, 2016.

The final design phase will begin with our field crews performing ground surveys to tie the existing road and driveways, drainage features, inlets, utilities and other topographic items. We will then begin the preparation of construction plans, specifications, bidding and contract documents for the roadway reconstruction. The existing drainage basins will be delineated and drainage calculations will be calculated for the 100-year storm event. Drainage improvements will be recommended if the existing infrastructure is under capacity.

Part I: Preliminary Engineering

- A. Utilize aerial image to approximate existing horizontal alignment of the roadway.
- B. Run AutoTURN simulations with a 36-ft school bus as the design vehicle.
- C. Prepare schematic exhibit illustrating the proposed paving geometry.
- D. Prepare updated Opinion of Probable Project Cost

Part II: Final Design Phase

- A. Coordinate Dig-Tess to locate utility lines along the project.

- G. Prepare a removal & relocation plan
- H. Prepare Erosion Control Plan
- I. Prepare Standard & Special Details
- J. Prepare Cover Sheet, Location Map and Sheet Index
- K. Submit construction plans to franchise utility companies and incorporate comments received.
- L. Complete quantity take-off and prepare Opinion of Probable Construction Cost
- M. Preparation of Proposal and Bid Schedule, Contract Documents and Specifications.
- N. Submit three (3) copies of the Preliminary Bidding document book and Preliminary Plans on 11-inch x 17-inch sheets for review by the City.
- O. Revise plans based on City comments and respond to each comment not incorporated in revised plans or bidding book.
- P. Submit three (3) sets of Final Specifications and Bidding Documents and Final Plans on 11-inch x 17-inch sheets.

Part III: Bidding Phase

- A. Assist the City staff in advertising for bids. This will include consultant emailing "Notice to Contractors" to contractors experienced in this type of construction. Engineer to provide City with Notice to Contractors to publish in the local newspaper.

- C. Respond to plan holder questions as necessary.

- D. Prepare and issue bidding document addenda as required.
- E. Attend project bid opening.




Exhibit "E" Project Location Map

CAPITAL IMPROVEMENT PLAN (CIP) POLICIES AND PROCEDURES

Introduction

The City of Lucas Capital Improvement Plan (CIP) is a valuable part of the community planning process. The CIP links local infrastructure investments with comprehensive plan goals, land use ordinances and economic development efforts. The CIP bridges the gap between planning and spending, between the visions of the comprehensive plan and the fiscal realities of improving and expanding community facilities. The purpose of the CIP policy is to create a fair and consistent process outlining procedures for proposing, evaluating, and adopting capital projects creating long-term benefits.

The CIP is a five-year planning document adopted by the City Council to plan for capital improvements related the City's street and drainage system, water system infrastructure and facilities. The CIP is not to be confused with the Capital Improvement Budget. The Capital Improvement Budget is prepared each year in conjunction with the annual Operating Budget. It generally includes only those projects from the first year of the CIP funded during the current year.

A capital project is defined as having a minimum cost of \$5,000 resulting in 1) the creation of a new fixed asset; or 2) an enhancement to an existing fixed asset.

Typically, the life expectancy of a capital project is 20 years but it depends on the classification of the asset. Examples of capital projects include construction or expansion of public buildings, the acquisition of land for public use, planning, waterline/water system improvements, sewer as defined in the wastewater plan, engineering costs and street and drainage construction.

Goals

- 1. Preserving public welfare and safety Providing the basic services that ensure public welfare and safety is the fundamental responsibility of local government. The cumulative effect of deferring investment in needed infrastructure and basic improvement of essential services is often an expensive series of stopgap measures that fail to address comprehensive, long-term needs.
- 2. Anticipating the demands of growth When related to the comprehensive plan, the capital improvement planning process works to anticipate investments in community facilities and infrastructure which are needed to serve or shape the pattern of growth and development.
- 3. Supporting economic development Communities having sound fiscal health and high quality facilities and services are attractive to business and potential residents. New corporate investment and reinvestment in a community may be influenced by improvements that enhance the quality of life for their labor force. Private decisions that bring jobs to an area and new taxes to a community are based not only on

availability of water and sewer, but also upon the quality of schools, public safety, recreation opportunities and many other services. The City of Lucas has identified two area for commercial development that is located on its peripheral boundaries to complement the high quality of life and not hinder or negatively impact it.

- 4. Developing a fair distribution of capital costs The CIP process allows for public discussion of the preferred means of distributing capital costs not only over time. Funding strategies to consider include:
 - a. Annual appropriations to capital reserve accounts to save for future projects.
 - b. Issuance of debt that is returned by both existing and future users of the facility.
 - c. User fees may be deemed more appropriate than property taxes.
 - d. Federal or state funds may also be available to help finance specific projects.

The CIP process can promote discussion of funding strategies.

5. Avoiding undue tax increases - Capital improvement planning is a means of avoiding the unpleasant surprise of expensive projects generating large property tax increases. While cost impacts cannot always be precisely determined in advance, the CIP fosters discussion of the distribution of the tax burden of new capital expenditures over time. A corollary benefit of fiscal stability and sound community facility planning can result in an improved bond rating.

Development Process

The CIP plan outlines the major utility infrastructure, streets and drainage, facilities, parks and other improvements needed to serve the citizens, meet growth related needs and comply with state and federal regulations.

Preparation - The Finance Director coordinates the annual update and adoption of the five-year Capital Improvement Plan (CIP) as a part of the annual budget process. The City Manager will lead the review and prioritization of capital projects for City Council consideration. The Finance Director, City Engineer, Development Services Director and the City Manager shall prioritize and rank projects according to the criteria listed in project criteria section. The CIP includes all costs associated with the design, rights-of-way acquisition and construction of a project, as well as the estimated operating and maintenance costs, which impacts future operating budgets. The following guidelines will be utilized in developing the CIP:

- 1. Identify capital improvements and major maintenance projects through system models, repair and maintenance records and growth demands.
- 2. Prioritize CIP projects based on input from City staff from all operational areas related to each project and its effect on operations.
- 3. Solicit citizen participation in formulating the identification and prioritization of the CIP.

The CIP will be submitted to City Council for review, revision and approval. It will be reviewed

and revised annually to include updated information.

Control – All capital project expenditures must be appropriated in the capital budget. The Finance Director or City Manager must certify the availability of resources before any capital project contract is presented to the City Council for approval.

Financing Programs - Recognizing that long-term debt is usually a more expensive financing method, alternative financing sources will be explored before debt is issued. When debt is issued, it will be used to acquire major assets with expected lives which equal or exceed the average life of the debt issue. Where applicable and appropriate, impact fees, assessments, prorata charges or other fees should be used to fund capital projects.

Reporting - Periodic financial reports will be prepared to enable the Department Directors to manage their capital budgets and to enable the Finance Department to monitor and control the budget as authorized. Capital project status reports will be presented to City Council.

Capital Improvement Plan (CIP) 2016-2020

Departments will include as part of their project proposal:

- 1. A Project Summary providing an overview and justification of the project.
- 2. A Fiscal Overview that includes estimated cost estimates and funding strategies that proposes funding options must be identified including:
 - a. Operating Revenues
 - b. Reserves and/or Debt
 - c. Grants
 - d. Partnerships with Other Organizations
 - e. Impact Fees
 - f. Developer Funded

Expense estimates must be identified in the section for design, site acquisition, construction, and estimated annual maintenance and operating cost impact based on the current estimated cost and values. To help manage cash flows, the financial plan must be complete to ascertain the impact on multiple fiscal years.

- 3. A Project Description section will provide additional project detail such as estimated linear feet, square feet or other applicable measurement, language that explains the overall need for the project as well as the benefit to the community.
- 4. Proposed Schedule identifying major milestones such as the design, bid, and construction phases.
- 5. Identification of the Project Manager.

Additional information may be requested by the City Manager and/or the members of the Lucas City Council.

Project Criteria

The evaluation of proposed capital projects will be in accordance with the following criteria. Attachment A provides criteria scorecard used in evaluation process.

- 1. Public Welfare and Safety Project improving the public welfare and safety of the community will be rated with highest priority. Projects must demonstrate the benefit provided to the community and possible risks from not completing the project. Compliance with state and federal mandates fall under this category.
- 2. Economic Development Projects enhancing and promoting the establishment of commercial business with the highest and best use for a parcel of land that is zoned commercial will be given the highest priority.
- 3. Quality of Life Projects enhancing the quality of life enjoyed by Lucas citizens, such as equestrian/hiking trails throughout the city, will receive a high priority.
- 4. Funding Funding availability considerations are included when ranking projects. Grants and funding partnerships are considered first followed by operating revenues, fund balance, and debt. Fund balance may only be used to fund capital projects if the use of reserves will delay or eliminate a proposed bond issue and sufficient fund balance exists to provide necessary contingency reserves. Debt may be issued to fund non-continuous capital projects benefitting future citizens only after alternative funding sources are explored.
- 5. Service and Operational Impact The service category prioritizes projects including promotion of improved service delivery or reduction of increase maintenance costs including rehabilitating aging infrastructure. A cost-benefit analysis shall be done to weigh the impact of project rehabilitation to determine if the project will reduce future ongoing maintenance costs. Performance data will also be analyzed when considering projects related to improved service delivery. Future operation and maintenance expenses will be considered as part of this analysis.

CIP Amendment

Amendments to the CIP effecting the current fiscal year must be recommended by the City Manager and approved by the City Council through a budget amendment. Amendments will be considered according to project scoring criteria as previously identified. Higher priority will be given to projects necessary for the public welfare and safety, desirable economic development, and funding availability.

It needs to be recognized that any plan for the future must be based upon an estimate of certain characteristics. These characteristics may change and vary from time to time and when they do, the CIP should be updated. It may require that certain proposed improvements be implemented immediately or even delayed. Further, this plan is meant to be flexible; to be used as a tool to help establish a course of action. The highest need capital improvement projects recommended

during the next five years focus on correcting and improving the existing infrastructure. The remaining capital improvements, including those which will be accomplished after the initial five-year plan, are presented in the applicable sections of this document.

Capital Needs Prioritization

Using the criteria identified in the Project Criteria section of this document will assist staff and ultimately the elected officials in rating each project to facilitate prioritization.

There are various rating schemes available for establishing capital improvements priorities. The following set of standards are used as the evaluation method for the City of Lucas:

- **Mandatory** or essential projects are activities needed to promote public welfare and safety. Projects classified under this category are projects of the highest priority.
- Necessary capital improvements are projects which are necessary for the convenience and
 conservation of endangered resources, or for the completion of partially completed
 projects. Projects of this type include improvements which are considered necessary for a
 progressive growing community and for problems that do not endanger life or negatively
 impact public welfare.
- **Desirable** capital improvements are projects which protect property, replace obsolete facilities, reduce operating costs and add to the attractiveness of the community. Projects of this type are not considered absolutely necessary and may be delayed, or removed from the capital improvements program, as funding changes. Conversely, these types of projects can be brought forth when budget surpluses or additional funding sources are identified.
- **Deferrable** projects are capital improvements of the lowest priority. These projects can be postponed or eliminated from the capital improvements program because of cost, timing, or need.

A summary of the City's infrastructure needs is contained in each element of the Comprehensive Plan. The capital needs outlined here represent only those improvements which should be accomplished within a specific period of the CIP.

Community Interest

2. Community Interest Items:

Mayor Olk presented a Proclamation to Girl Scout Troop 8938 for the Arbor Day event held at the Lucas Community Park on November 12, 2016.

Mayor Olk announced that the City's Country Christmas event would be held on December 2, 2016 from 6:00 pm to 9:00 pm at the Community Park.

Public Works Director/City Engineer Stanton Foerster informed the City Council that drilling for the footings had begun at the Blondy Jhune Bridge and during the drilling process, an AT&T line

was found in the location for the footings. Mr. Foerster noted that contingency funds would be used to move the line and keep the project on time.

Development Services Director Joe Hilbourn informed the City Council of staff concerns related to recent water registers that had either failed or had no readings during the last month. Mr. Hilbourn stated that approximately 260 registers had no readings and 42 registers had failed. Mr. Hilbourn explained that water consumption would be estimated for those customers whose registers had not readings and staff was researching for other providers.

Mayor Olk asked that staff notify all residents whose accounts would be estimated.

Consent Agenda

- 3. Consider approval of the minutes of the November 3, 2016 City Council meeting.
- 4. Consider approving an expenditure to purchase two emergency response vehicles from Bob Tomes Ford in the amount of \$83,400.00 to replace a 2003 Chevy Tahoe and a 1991 Ford F-350 Rehab truck approved in fiscal year budget 2016-2017 from account 11-8300-421.

MOTION: A motion was made by Councilmember Fisher, seconded by Councilmember Millsap to approve the Consent Agenda. The motion passed unanimously by a 7 to 0 vote.

Regular Agenda

5. Discuss options available to the City of Lucas concerning the Statutory Maximum Rate of Contribution for funding the Texas Municipal Retirement Services for 2017 and consider adopting Ordinance 2016-11-00844 removing the TMRS Statutory Maximum Contribution.

Collin Davidson, Regional Manager with TMRS, discussed with the City Council the various options available regarding contribution rates for the City's retirement plan outlined below:

- 1. Remove the Statutory Maximum Contribution Rate by ordinance increasing the statutory maximum rate by 2.0% to 15.50%.
- 2. Increase the Statutory Maximum Contribution Rate, by ordinance annually every year, with a 15.5 percent cap.
- 3. Pay the Retirement Cost Contribution Rate each year on a "one-year-at-a-time option causing annually repeating benefits (updated service credits for employees and COLA increases for retirees) to be turned off.
- 4. Pay only the Statutory Maximum Contribution Rate of 13.50% causing annual repeating benefits (updated service credits for employees and COLA increases for retirees) to be turned off.

Mr. Davidson discussed with the Council actuarial changes, level and cost of current benefits, and long term impacts. The City Council also discussed current statutes and legislation in place.

MOTION: A motion was made by Mayor Olk, seconded by Councilmember Baney to choose Option No. 2, placing a 15.5 percent cap on contribution rates and drafting an ordinance for approval. The motion passed unanimously by a 7 to 0 vote.

6. Consider a variety of transportation survey questions and decide which to be posed to the citizens of the City of Lucas and provide guidance to staff on how to administer the transportation survey, prior to the Transportation Town Hall meeting on January 26, 2017.

Mayor Pro Tem Peele suggested keeping the survey to a maximum of ten questions and focus questions on regional transportation issues. Mayor Pro Tem Peele suggested the City Council formulate their questions and provide those to Public Works Director/City Engineer Stanton Foerster to have available at the December 1, 2016 City Council meeting.

Mayor Olk suggested questions also focus on the types of streets desired along with the width of the street, and remove questions related to equestrian trails and funding of new road construction.

Mayor Olk noted comments received by Tim Johnson, 2175 Toole stating that questions should be related to cut-through traffic and traffic related to FM roadways, connector streets and residential streets.

MOTION: A motion was made by Mayor Pro Tem Peele, seconded by Councilmember Lawrence to provide suggested questions to the Public Works Director/City Engineer to include as part of the December 1, 2016 City Council meeting for discussion. The motion passed unanimously by a 7 to 0 vote.

Mayor Olk moved to Agenda Item No. 8 at this time.

8. Update and provide guidance to staff regarding repairs to a 1940s fire truck commonly referred to as "Streaker" for use during special events.

Development Services Director Joe Hilbourn stated that staff had restoration of Streaker with the removal of the engine and transmission at a total cost of \$600 thus far.

Friends of the Lucas Fire-Rescue Board members Kathleen LoSapio and Paul Rathgeb stated that the board was raising funds to be used towards the restoration of Streaker, and have obtained an estimate in the amount of approximately \$8,000 for repairs; however, the estimate did not include engine work.

City Manager Joni Clarke stated that the vehicle is listed as a fixed asset for the City and any work done by the Friends or the Lucas Fire-Rescue Board would be considered a donation.

The City Council discussed the level of restoration needed and that further estimates should be acquired regarding a full restoration.

Councilmember Millsap discussed concerns related to placing an engine from another vehicle into Streaker that could make it difficult to restore other items on the fire truck. Councilmember Millsap suggested discontinuing restoration by staff until further estimates and an outlined plan could be determined.

Captain Ethan Carver, Lucas Fire-Rescue Department discussed costs associated with repainting and making the vehicle drivable that were estimated between \$7,000 to \$12,000.

Mayor Olk asked that the Friends of the Lucas Fire-Rescue Board come back to the Council with an estimate of the level of restoration needed, costs associated with the restoration, and the level of participation anticipated by the Friends of the Lucas Fire-Rescue Board.

Mayor Olk directed staff to delay restoration efforts to allow time for the Friends of the Lucas Fire-Rescue Board to obtain estimates and outline a timeline for restoration.

7. Discuss and give direction to the City Manager regarding the following:

- A. North Central Texas Council of Governments Regional 10-Year Plan
- B. Purpose of \$200 million as a placeholder in said plan for a north/south arterial west of Lavon Lake in Collin County
- C. Possible action relating to same before the Regional Transportation Council (RTC) in December 2016 and the Texas Transportation Commission (TTC) in February 2017

Public Works Director/City Engineer Stanton Foerster stated that staff attended the North Central Texas Council of Governments (NCTCOG) Regional 10-Year Plan meeting that laid out plans for the \$6.98 billion in transportation funds to be spent by 2040. Mr. Foerster noted that the first step in the plan was to list projects for the next 10 years. The NCTCOG staff proposes to set aside \$200 million for projects in Collin County and for the North/South Arterial with limits set to west of Lake Lavon. Collin County Roadway Action Plan No. 4 proposes setting aside funds in the amount of \$100 million for Urban Mobility Corridors and \$100 million for Commission Strategic Priority projects.

Mr. Foerster discussed modifications to the plan that he requested from the NCTCOG and that the NCTCOG would request approval of the 10-year plan including the \$200 million from the RTC on December 8, 2016 and from the Texas Transportation Commission in February 2017.

Mayor Olk directed staff to prepare a letter outlining modifications to the plan that the City of Lucas would like to discuss with Regional Transportation Council representative Allen Mayor, Stephen Terrell.

- Appoint Joanne Doucet as an alternate member for a two year term beginning January 1, 2017 through December 31, 2019.
- Accept resignation of Valerie Turnbow

The motion passed unanimously by a 6 to 0 vote.

Mayor Olk directed staff to setup interviews with Brian Blythe and Tommy Tolson for the December 15, 2016 City Council meeting during Executive Session.

The City Council discussed possible ways to recruit in the future including discussions at future Town Hall meetings and active recruitment from Council members.

6. Consider approval of the request by Steve Lenart on behalf of Lenart Development, LLC for preliminary plat approval of Enchanted Creek Estates, located on the north side of Parker Road between Stinson Road and FM 1378. The parcel of land being 135.743 acres and part of the James Anderson Survey Abstract No. 17, and the John McKinney Survey Abstract No. 596.

Development Services Director Joe Hilbourn gave a brief presentation noting that the property was zoned R-1 and was proposing 66 lots with a lot density of one lot per 2.057 acres. Mr. Hilbourn noted two changes were proposed from the original concept plan requested by the City Engineer. Those changes included reducing the number of bridges from two to one, and adding a roundabout at the main intersection of the subdivision.

The City Council discussed various questions that could be posed to the citizens regarding future transportation needs. The Council also discussed focusing on the thoroughfare plan and discussing a broader range of questions, rather than discussing smaller neighborhood streets at this time.

The City Council agreed to compile information and create survey questions after the Transportation Town Hall meeting on January 26, 2017.

[CONTRIBUTIONS TO TEXAS MUNICIPAL RETIREMENT SYSTEM]

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LUCAS, COLLIN COUNTY, TEXAS, INCREASING THE MAXIMUM COMBINED RATES OF THE CITY'S NORMAL CONTRIBUTIONS AND PRIOR SERVICE CONTRIBUTIONS TO THE TEXAS MUNICIPAL RETIREMENT SYSTEM PURSUANT TO SECTION 855.501 OF TITLE 8, TEXAS GOVERNMENT CODE, AS AMENDED; AND PROVIDING FOR AN EFFECTIVE DATE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LUCAS, COLLIN COUNTY, TEXAS, THAT:

Section 1. Pursuant to the provisions of Section 855.501(j) of Subtitle G of Title 8, Texas Government Code, as amended (which Subtitle shall herein be referred to as the "TMRS Act"), the City of Lucas, Texas, agrees to be liable for the combined normal contribution rate and prior service contribution rate for the City's participation in the Texas Municipal Retirement System (herein referred to as the "System"), as those rates are approved by the System's Board of Trustees from time to time under the provisions of the TMRS Act, provided that the combined rate does not exceed 15.50%.

Section 2. This Ordinance shall take effect on January 1, 2017, in accordance with the provisions of the Charter of the City of Lucas.
